MILLER:** Just a few small matters. 4 I've been handed a PowerPoint for the next witness, the last 5 witness for the defendants, Dr. Levine. 6 THE COURT: Uh-huh. 7 MR. MILLER: Well, we got a detailed report 8 9 from Dr. Levine. We took Dr. Levine's deposition. And the other objection is this EPA report, I 21 quess you would call it, that came out last week by --22 signed by Billy Mitchell. Apparently, Billy has a 23 bachelor's degree and --24 THE COURT: I'm sorry. Who is Billy Mitchell? 25 5059

MR. MILLER: He works at the EPA. 1 THE COURT: Is that the subject of the motion 2 3 that was filed at the end of the week? MR. MILLER: It is. 4 THE COURT: 5 Okay. MR. MILLER: And the report is rifled with 6 violations to the motions in limine. They talk about 7 the EPA standard dose and how --8 THE COURT: Well, let me stop you. 9 Because the reason I didn't even address that was because I was 10 waiting for plaintiffs to file an opposition. 11 There's 12 really no way for me to review it and give it any thought. 13 So are you going to file something, or is this 14 just going to be the subject of an oral motion, and/or 15 is this something that Dr. Levine is going to testify 16 17 to? And, therefore, they should consider the evidence that has come in as being 21 equivocal or just preliminary and not final. 22 They had Dr. Benbrook make that assertion. 23 Mr. Wisner made that assertion in opening statements. 24 25 In fact, he even suggested that the outcome here may 5061

1 have some sort of influence on the EPA's determination. 2 This here is a response to -- specifically 3 with Dr. Benbrook. Dr. Portier mentioned it is the OPP report that's in evidence. It should be downgraded, I 4 quess, in significance because -- their characterization 5 that it's not final. 6 We have here reaffirmation of that position by 7 the EPA in 2019 considering public comment that has been 8 made. And, because of that, it is directly responsive 9 10 to questioning in evidence that the plaintiffs have put in about the earlier report. 11 It's not a final. 12 MR. MILLER: If it was a 13 final, then maybe we could consider it at some other argument or level. But the registration process will continue; the public comment process will continue. 18 It's nothing final in this document; it's 19 20 simply something that mysteriously appeared last week. 21 And it says the same stuff that the other two say. So I think the dating issue is correct. 22 I'm going to just take a break and 23 THE COURT: take a look at it. Tentatively, I would say no. If 24 it's not a final decision by the EPA, then I don't see 25 5062

ISMAIL: I am handing you a binder of some exhibits 2 ο. we're going to go through today. 3 I've provided a copy to counsel, and Your 4 Honor has a copy as well. 5 Good morning, Doctor. 6 Good morning. 7 Α. Can you please introduce yourself to the 8 ο. 9 ladies and gentlemen of the jury and tell the folks what you do for a living. 10 My name is Alexandra Levine. 11 I am an A. 12 oncologist. That means that I take care of patients who 13 have cancer. I work at the City of Hope National Cancer That is in Duarte outside of Los Angeles. 14 Center. Ιt 15 is a comprehensive cancer center that is supported by the National Cancer Institute. 16 17 And, Dr. Levine, do you have a particular area Q. of focus within the field of oncology? 18 My specialty is non-Hodgkin's lymphoma 19 A. Yes. 20 and Hodgkin's lymphoma as well. And, Doctor, have we asked you to look at the 21 0. medical records with respect to Mr. Pilliod and some 22 23 scientific information regarding Roundup to form an opinion as to whether or not Roundup played any role in 24 his development of non-Hodgkin's lymphoma? 25

Yes, you did. 1 A. And are you prepared today to discuss with the 2 ο. 3 jury your opinions and your findings on those questions? I am. 4 Α. And before we get to your opinions, Doctor, I 5 Q. would like to give folks a little bit better sense of 6 your professional experience and background. 7 And I notice, Doctor, you have a CV that is 8 9 over a hundred pages long. And rather than walking through the CV, have you helped us put together some 10 slides to summarize your professional experience? 11 Yes, I did. 12 Α. 13 So they're in the binder there in the front, 0. but I'll also show them on the screen here for you. 14 Can you please tell us -- let's start with 15 16 your education and early professional medical training. 17 First, undergraduate, I went to UC Berkeley, Α. right close to here. 18 After that, I went to University of Southern 19 20 California, USC, for medical school. After medical school, you are an intern. 21 You're still being trained as an intern and then what's 22 called a resident. So I was an intern and a resident in 23 24 internal medicine at the big Los Angeles County USC Medical Center, the big county hospital for the County 25

of Los Angeles.

2	After that, if you want to specialize more
3	within the field of medicine, you take a fellowship.
4	And that allows, again, more sophisticated training.
5	I became a fellow in hematology and oncology
6	at Emory University in Atlanta, in Georgia. And, after
7	that, I came back to Los Angeles, came back to the big
8	county hospital. And I was a fellow in clinical
9	research in hematology, specifically cancers of the
10	blood system. And that was at the county hospital
11	again.
12	Q. So, Doctor, what sparked your interest in
13	oncology?
14	A. It's a long question a long answer, I
15	guess. Basically, I've always been challenged by
16	people, patients who have complicated illnesses who are
17	a challenge. It's something that is interesting to me,
18	the challenge of significant illness.
19	The second thing I learned earlier in my
20	training was that, if somebody was really ill, somebody
21	with cancer, as an example, and you had the time or
22	wanted to take the time just to sit at the bedside and
23	hear, you could hear all of life. You could hear what
24	was important, what isn't important.
25	And so the human aspect was very moving to me,

and the challenge of difficult disease was moving to me. And I think those were the two main things that got me into oncology.

Q. And did you begin -- at that point in your fellowship back at Emory and probably even your earlier training, beginning caring for patients with cancer in the manner that you just described?

A. Yes. So I -- the county hospital is big. It
was 2,000 beds at that time. I had a tremendous amount
of experience with cancer patients even before I took
the fellowship. That's what told me that I wanted to go
in that direction.

13 Q. So let's talk about your clinical experience,
14 Doctor.

15 After your fellowship, did you continue your16 practice in caring for patients with cancer?

A. Yes, I did.

Q. Can you walk us through the clinical positionsyou've held and your experience at those hospitals?

A. First of all, at the county hospital, I became
the clinical director of the adult hematologic neoplasia
service. What that means is I was in charge of the care
of the patients, all of the patients who had cancers of
the blood system: leukemias, lymphoma, multiple
myeloma, diseases such as that.

And that was many years. That was from 1997 1 2 until I left USC at the end of 2006. 3 In time, I became the interim chief of the division of medical oncology. That really was not my 4 field. They were recruiting for a director, and I 5 agreed to be the interim for that year. 6 What I really did, from 1991 through 2006, I 7 became chief of the division of hematology. I was in 8 9 charge of the whole area of hematology at USC. 10 Then -- in 1983, USC opened their first private hospital, a cancer hospital, USC Norris Cancer 11 12 Hospital. And at first I was the deputy clinical 13 director of the cancer center in general, and then I became the medical director of USC Norris Cancer 14 15 Hospital. And I did that from '96 to 2006, when I left USC. 16 17 I left at the end of 2006 and I went to City of Hope. I was asked to be the chief medical officer at 18 City of Hope. And at the end of 2016, I -- at 12/31/16, 19 20 I retired from the administrative positions, could never 21 really retire from being a doctor. So I continue to take care of my patients, even though I'm no longer the 22 23 medical director of the cancer center there at the hospital there. 24 So as you've described your clinical 25 0.

experience here on this slide from 1977 to the present, throughout that entire time, did you continue your clinical practice caring for patients with cancer?

I really couldn't do what I do if I wasn't a 4 A. doctor. And, as an example, when I was chief of the 5 division of hematology, I was in charge of making the 6 schedules for all the doctors. The hardest schedule 7 would be to be an attending physician at the county 8 9 hospital. And I specifically made myself the attending for six months out of the year. I love taking care of 10 I've always taken care of patients. And I 11 patients. 12 still take care of patients.

13 Q. That was going to be my next question. Even 14 though you have stepped down as the chief medical 15 officer at City of Hope, do you continue to this day 16 being a clinical physician in oncology?

A. Absolutely. The last time I got a call from apatient was last night.

19 Q. And when are you next going to be in clinic or 20 in the hospital taking care of patients?

A. Tomorrow, my first appointment at 7:00 a.m.
Q. And throughout this time, Doctor, this
40-plus-year career you've had as an oncologist, what
has been your area of clinical specialty?

A. My clinical specialty is non-Hodgkin's

1 lymphoma. That's what I do.

2	Q. And this is probably a difficult question to
3	answer, but, as you look back over your four-plus
4	decades as a clinician, can you give us a sense of the
5	number of parents with non-Hodgkin's lymphoma that you
6	have seen and cared for?
7	A. I don't know exactly. It is thousands. It is
8	literally thousands, starting from the county hospital,
9	being ultimately in charge of all of those patients who
10	had non-Hodgkin's lymphoma. The interns, the residents,
11	the fellows, the other attendings would come to me. I
12	knew those patients over time.
13	So it is literally tens of thousands of
14	patients.
15	Q. Now, the jury has had an opportunity to meet
16	another physician at City of Hope named Dennis
17	Weisenburger.
18	Do you know Dr. Weisenburger?
19	A. I certainly do.
20	Q. How do you know Dr. Weisenburger?
21	A. I know him as a colleague, as a pathologist.
22	I know him also because I was in charge of recruiting
23	all the physicians, the quality of their work and so
24	forth, and I recruited Dr. Weisenburger to be chief of
25	pathology at City of Hope.

Q. So you, in essence, hired Dr. Weisenburger? 1 2 I certainly did. Α. 3 And as chief medical officer at City of Hope, 0. were you responsible for all the physicians at that 4 hospital? 5 6 Α. The physicians reported to me. Yes. I was responsible for the clinical care that they delivered. 7 I was responsible for the quality of their care. I was 8 9 responsible for the research that they did. I was 10 responsible for assuring that they were abiding by all 11 the rules and regulation and so forth. 12 Q. Do you respect Dr. Weisenburger as a 13 pathologist? I absolutely respect Dr. Weisenburger as a 14 Α. 15 pathologist. 16 Now, at City of Hope do the pathologists 0. 17 become involved in diagnosing the cause -- assessing the clinical risk factors of a patient and diagnosing the 18 cause of those patients' non-Hodgkin's lymphoma? 19 20 Α. No. It is not the role of the pathologist to diagnose a cause of an illness. The role of the 21 pathologist is to diagnose the illness in the first 22 23 place by looking under the microscope, by looking at laboratory tests and so forth, and diagnosing what that 24 That's what a pathologist is supposed to 25 patient has.

1 do and does.

2 Is that true for Dr. Weisenburger as well in Ο. 3 your experience --Yes, it is. And that's why he was hired. 4 A. And at City of Hope, what is the group of 5 Q. physicians who do became involved in assessing a 6 patient's clinical presentation and trying to understand 7 what's going on with their cancer? 8 9 Α. That would be the oncologist. That would be 10 the clinician who talks to the patient, who understands what the patient's history has been, medical history and 11 12 so forth, and tries to put it all together in a way that will be helpful. 13 And is that an area in which you've worked in 14 ο. 15 for the nearly last 50 years? Α. Yes. 16 17 Do you also have roles as a teacher? Q. Yes, absolutely. 18 Α. Can you walk us through your teaching 19 Q. 20 positions and the areas in which you were instructing 21 young medical students and doctors? Yes. First of all, I love to teach. 22 Α. I always 23 teach. As it turns out, the word "doctor" comes from the Latin which means teacher. So that's part of my 24 25 job, and it's always been part of my job to me, 5080 1 important to me.

2	At USC, first I was an assistant processor and
3	then an associate and then a professor. And in 1977 I
4	was designated as a distinguished professor of medicine.
5	That's an honorary kind of degree.
6	Right now, since I've left USC, I'm called a
7	distinguished professor emeritus. In 2010 I also became
8	an adjunct processor at Claremont Graduate University.
9	That means I'm not fully employed there, but I teach
10	there and work in some sense there.
11	In 2007, when I started at City of Hope, I
12	became a professor of hematology, oncology, and
13	hematopoietic cell transplantation. That means like
14	bone marrow transplant.
15	Then in 2012 I was given another honorary
16	degree or honorary title, Melinda and Norman Payson
17	Professor of Medicine.
18	So those are the titles that speak to the fact
19	that I have been a teacher over those many years.
20	Q. And who is it that you teach?
21	A. I teach everybody. I teach the community. I
22	teach patients. I teach the families of patients. I
23	teach undergrad students. I teach medical students
24	extensively. I teach interns, residents, fellows. I
25	teach other physicians quite regularly, actually, in
	5081

1 community settings or in big national or international I teach a lot. 2 conferences. And has your teaching experience also focused 3 0. in the area of lymphomas and blood-related cancers? 4 Α. Yes, it has. 5 6 Tomorrow morning, when you are seeing your Q. patients, will you have residents or fellows with you? 7 A. Usually I'll have a fellow with me. 8 I don't 9 know exactly who's assigned tomorrow. In addition to your clinical experience you've 10 Q. described, your teaching experience you've just 11 described, have you also been involved in research? 12 Yes, I have. 13 Α. Can you tell us what has been your focus in 14 Q. 15 your areas of research? 16 My general focus in research is non-Hodgkin's A. 17 lymphoma. As time went on, I became involved in the 18 area of what causes lymphoma in terms of various germs, various viruses and organisms. 19 20 Q. Have you published your work in the peer-reviewed medical literature? 21 Yes, I have. 22 Α. 23 Let's just break this down. 0. 24 How many peer-reviewed articles have you published in the literature? 25 5082

1	A. About 325, 326.
2	Q. And have you also published contributed
3	book chapters to textbooks in medicine?
4	A. Yes, I have.
5	Q. Can you give us a sense of that order of
6	magnitude?
7	A. 70 of those. I get requests to do that. It
8	takes a long time to write a chapter, and at a certain
9	point in my career, I decided that I would only write
10	one chapter a year. So that was limited to 70.
11	Q. Have you also published abstracts in medical
12	journals?
13	A. Multiple, multiple abstracts in medical
14	journals, yes.
15	Q. Can you give us a sense of the order of
16	magnitude of that contribution?
17	A. At a certain point, I didn't even put them on
18	my CV. There were too many of them. Every paper I
19	wrote would have started with abstracts, beginning of
20	the information, beginning to understand, publishing
21	those preliminary data and then eventually the whole
22	publication. I will say it's probably in the order of
23	900 or 1,000, perhaps, abstracts.
24	Q. So, in total, looking at how published is
25	Dr. Levine in the medical literature, can you give us a
	5083

1 sense of peer-reviewed journal articles, abstracts, book 2 chapters? 3 A. Well over a thousand publications, peer-reviewed. 4 Have you -- has your work publications 5 Q. appeared in some well-known medical journals like the 6 New England Journal of Medicine and Journal of American 7 Medical Association? 8 9 Α. Yes, they have. Have you served as an editor for any of the 10 Q. journals the jury may have heard about during this 11 trial? 12 Yes, I have. 13 Α. For example? 14 Q. 15 Oncology. A. The jury has heard about the peer-reviewed 16 Q. 17 process and how articles are sent out for comment by experts in the field. 18 19 Have you had an opportunity to do that as well? 20 I do that very, very regularly. 21 Yes. The Α. last paper I was asked to review was last week. 22 So many, many, many. Hundreds of thousands, I would 23 think -- not hundreds of thousands, but perhaps a 24 thousand of those reviews over 40 years. 25 5084

1 Q. Have you -- I think you mentioned as well that 2 you have presented on your areas of expertise to other 3 physicians? Α. That's correct. 4 And you've been asked to speak at conferences 5 Q. 6 about non-Hodgkin's lymphoma? Yes, conferences both nationally and 7 Α. internationally. 8 In your speaking experience, has the topic of 9 0. 10 pesticides come up? Speaking generally. 11 A. No. Have you ever told a group of physicians that 12 0. 13 Roundup causes non-Hodgkin's lymphoma? No, I have not. 14 Α. 15 Why not? Q. I believe that the majority of the data are 16 A. 17 clear in terms of the fact that Roundup does not cause lymphoma. 18 19 Now, Dr. Levine, your CV has many awards ο. listed on it. 20 I'd like to ask you, of all the awards that 21 are listed on your CV, which are the most meaningful and 22 23 significant to you? 24 I quess, first related to teaching, the A. Outstanding Clinical Professor Award. So there aren't 25 5085

nominations; the students just pick whatever name they want to pick and vote. And at a certain point, the school made a decision that I was not allowed to receive this more than every five years. But then, when I was going to leave, they allowed that to occur. And that was important to me because teaching is important to me. 6

I was chosen by President Clinton to be a member of his advisory committee on HIV/AIDS and was 9 chosen to be the chairman of the research committee, of 10 that AIDS advisory committee. That was important to me.

11 I was elected a master of the American College 12 of Physicians. And that was important to me because it 13 spoke to my care of patients and the full -- what I did in my career. 14

15 And I quess the most recent one was in March 16 of this year, the Margaret Kripke. It was called the 17 Legend Award for Promotion of Women in Cancer Medicine and Cancer Science. And that was important for me 18 19 because I really do think it's important for women to be 20 involved in these fields.

In a certain kind of a way, I guess everyone 21 believes that nurses should be women because they are 22 23 kind and compassionate. Well, women should be doctors 24 too, and women should be scientists too. So that was 25 important to me that I was recognized for doing that.

1	Q. In addition to your work and your speaking,
2	have you also been asked to consult with health
3	ministries outside the United States?
4	A. Yes, I have.
5	Q. And we're showing here some of that work that
6	you have done?
7	A. Yes.
8	Q. Can you describe in general what that work is
9	and what you did in these points?
10	A. Early in the AIDS epidemic, I began to see
11	young men with very, very unusual non-Hodgkin's
12	lymphomas. And that was the beginning of my interest in
13	AIDS-related lymphomas. I eventually defined that these
14	lymphomas were going to be part of the AIDS epidemic,
15	and they were.
16	And as I got involved in the malignancies and
17	the cancer related to AIDS, you couldn't just get
18	involved in that; you had to look at the whole big
19	epidemic. And I became involved in the big epidemic.
20	And that meant that it was important to me to do
21	whatever else I could do to try to help any other
22	country, any other group to prevent that disease from
23	getting into that country in the first place.
24	So I very much was wanting to do these
25	consultantships in the various countries when I was
	5087

Г

asked to do so. I went to Mexico. I went to Chile. 1 Т was asked to speak to the health minister in India. 2 Т 3 went to Russia. I went several times to China. That was very interesting to me because I believed that, if 4 there was any one country in the world that might have 5 had the capability of stopping that epidemic from 6 occurring, it would have been China. But I failed. 7 It didn't work. I tried. 8

9 Q. And, Doctor, how is it or why is it that a
10 lymphoma specialist and cancer researcher, such as you,
11 became so involved in understanding the AIDS epidemic
12 and working on that as a public health issue?

A. Well, it started with my patient care. I saw
patients, and it just took one or two to realize that I
was seeing lymphomas that were very, very different than
any of the cases I had seen before.

That led me, after two or three cases, to look at population-based data. Was that just me at the county hospital seeing something funny, or was this really happening on a larger scale?

And I worked with some of the epidemiologists at USC. Leslie Bernstein, for example, was in charge of the SEER registry, which is a population-based cancer registry. If any doctor diagnoses cancer in my practice, it turns out that's a reportable disease to

1 the government. The government needs to track cases of 2 cancer. And you can see in a quick look whether there 3 are changes. Is something happening to the incidence of one kind of cancer or another? 4 So I looked at the SEER data, I looked at what 5 the CDC was also discussing, and realized that it wasn't 6 just my hospital; this was happening. 7 I started -- that was my beginning. 8 So starting with my own patients, realizing something 9 different, going to a larger dataset to see it wasn't 10 just me, and at that point trying to figure out what was 11 12 this? What was the emerging epidemic of a very, very 13 unusual lymphoma? And, again, as I said, it was very difficult. 14 It was such a difficult epidemic, such a difficult time 15 in the history of these people and in my life also. 16 You 17 couldn't just be involved in a little section of lymphoma and not get involved in the entire epidemic, 18 what was causing all of these infections and so forth. 19 20 0. Did this emerging issue, as you saw the 21 first -- the leading edge of it with respect to lymphoma, did that even have a name at the time? 22 At first it had no name at all. 23 Α. No. Eventually it was called GRID, gay-related immune 24 deficiency. And it turned out that it had nothing 25 5089

really to do with gay; it was just a sexually 1 2 transmitted disease or by blood to blood. 3 Eventually the name was changed to AIDS or became AIDS, acquired immune deficiency disease. 4 In time it was found to be caused by a virus, and that 5 virus was called the human immunodeficiency virus, HIV. 6 I actually wrote a letter to several people at 7 the NIH and CDC suggesting that the name of this virus 8 9 really should be HIV because, first of all, human, the only animal, if you will, that is infected by this virus 10 11 is people, is humans. Immunodeficiency. Immune is our immune system, our defense system. 12 This is a virus that 13 causes deficiency of the immune system in humans. And I thought that HIV was probably a pretty good name for it. 14 I wrote the letter, and subsequent to that, I 15 16 got a note from the Library of Congress asking if they 17 could put that letter into the Library of Congress, and I said yes. 18 Doctor, we're going to talk today with the 19 ο. 20 jury about the role of the immune system in cancer 21 surveillance and cancer protection; is that correct? 22 Α. Yes. Is that issue of the immune system how the HIV 23 0. and AIDS conditions affect the risk of a patient 24 developing lymphoma? 25 5090
It turns out that our defense system, 1 Α. Yes. 2 our immune system, is responsible for recognizing things 3 that are foreign to us. So, first of all, germs. It's your immune 4 system that will recognize that you have an infection, 5 see that it's foreign to you, and try to kill it for 6 And usually it will work in one way or another. 7 you. But it turns out that a cancer cell is also 8 9 foreign to you. There's been a change in that cell so that it doesn't look like self anymore, doesn't look 10 like me anymore. The immune system should be able to 11 recognize that, that that cell is foreign, and destroy 12 it. 13 And that's why people who have deficiencies or 14 15 abnormalities of the immune system are so at risk for 16 these various cancers. 17 Doctor, is it fair to say that you have over Q. 40 years of experience assessing patients and 18 recognizing whether or not their immune system puts them 19 20 at risk of developing non-Hodgkin's lymphoma? Yes, I have. 21 Α. Doctor, are you being compensated for your 22 Q. 23 time? Yes, I am. 24 A. 25 ο. At what rate? 5091

A. \$500 an hour. 1 In terms of the materials that you reviewed to 2 0. 3 arrive at your opinions you're going to talk about today, first with respect to Mr. Pilliod, did you 4 receive and review the medical records that were 5 provided? 6 Excuse me, Counselor. Are you 7 MR. MILLER: done with voir dire? 8 9 MR. ISMAIL: No. I'm establishing her materials that she reviewed. I will tender the witness. 10 11 MR. MILLER: Okay. MR. ISMAIL: May I continue, Your Honor? 12 THE COURT: Yes. 13 BY MR. ISMAIL: 14 15 Q. So, Doctor, my question, just so you have it 16 in mind, as part of your review in this case, were you 17 provided and did you review Mr. Pilliod's medical records? 18 They came at various time 19 A. Yes, I did. intervals. And I looked at them at various time 20 intervals when I received them. 21 Did you also look at his testing results as 22 Q. they were contained in his medical records? 23 Yes, I did. 24 A. Did you review the depositions of Mr. Pilliod 25 Q. 5092

2	A. Yes, I did.
3	Q. Did you review the depositions of physicians
4	for Mr. Pilliod?
5	A. I'm not sure I got all of them, but I think I
6	did, yes.
7	Q. And did you review the reports and depositions
8	of the experts that the plaintiffs have
9	A. Yes, I did.
10	Q tendered?
11	A. Yes, I did.
12	Q. Did you also review the scientific literature
13	and other information regarding glyphosate-based
14	products like Roundup?
15	A. I did.
16	Q. Did you also review some of the regulatory
17	organization reviews around the issue of whether
18	products like Roundup are related in any way to
19	non-Hodgkin's lymphoma?
20	A. Yes, I did.
21	Q. Did you review the IARC monograph as part of
22	your review?
23	A. Yes, I did.
24	Q. Did you also, Doctor, rely on your education,
25	training, and experience that you described for the jury
	5093

1 this morning in arriving at your opinions? 2 Α. T did. 3 **Q**. Did you have an opportunity to speak with Mr. Pilliod directly? 4 No, I didn't. 5 Α. And do you believe that in any way limits your 6 Q. ability to comment about his medical history and his 7 non-Hodgkin's lymphoma? 8 No, I don't think that at all. I was able to 9 Α. 10 go through his deposition carefully, and I certainly take him at his word with everything he said there. 11 And did his medical records provide you the 12 ο. 13 information you needed about his diagnoses and other related conditions over the years to form your opinions 14 in this case? 15 16 Α. It certainly did. 17 Doctor, all the opinions you're going to offer Q. today will be to a reasonable degree of medical 18 certainty? 19 20 A. Yes. And with respect to the opinions you have 21 ο. formed and that you will share with us today, did you 22 23 apply the same standards as you would with your own patients, your own students, your own colleagues when 24 you are a practicing oncologist and researcher? 25 5094

A. Yes, I did. 1 Doctor, are you familiar with the term 2 ο. "evidence-based medicine"? 3 Yes. 4 Α. What is that term? 5 0. 6 It means that, when we are making decisions Α. related to people, related to patients -- treatment 7 decisions, prognosis decisions -- we can't just think 8 that we -- I think I want to do this; I think I want to 9 do that. It has to be based on evidence. Somebody's 10 life is going to depend on you. And you need real data, 11 scientifically valid data. 12 And that's what "evidence-based" means. 13 It's not something I just think; it's something I know 14 because the science is there behind it. 15 And do you teach and practice the principles 16 0. 17 of evidence-based medicine in your roles that you described for us? 18 Without question. That is the basis of 19 A. 20 medical education. It is based upon scientific fact. Has to be. 21 And have you followed those concepts of 22 Q. 23 evidence-based medicine in your review and forming your opinions here? 24 Yes, I have. 25 Α.

1 MR. ISMAIL: Your Honor, at this time I would 2 tender Dr. Levine in as an expert in lymphoma, its 3 diagnosis, treatment, causes generally, and Mr. Pilliod specifically. 4 THE COURT: Voir dire. 5 6 MR. MILLER: Yes, Your Honor. Thank you. 7 VOIR DIRE EXAMINATION BY MR. MILLER: 8 Thank you. Good morning, Doctor. 9 0. 10 Α. Good morning. I'm Michael Miller. We haven't met. 11 **Q**. Hello. 12 A. This is my wife and law partner, Nancy 13 Q. Hi. Miller. She's going to help me a little bit. Okay? 14 15 Sure. A. You're the last witness, and we're going to be 16 ο. 17 done. And I just want to ask you a few follow-up. Now, first of all, I want to thank you for 18 everybody who has HIV or AIDS for your remarkable work 19 in that area. 20 Thank you for saying that. 21 A. No, I would disagree with that. 5 Α. 6 Do you remember us taking your deposition in Q. March, ma'am? 7 MR. ISMAIL: Your Honor, is this going beyond 8 9 the qualifications at this point? 10 THE COURT: Let's talk about qualifications 11 first. You may want to do that portion on cross-examination. 12 13 MR. MILLER: All right. BY MR. MILLER: 14 15 Have you testified for Monsanto before? Q. Yes, I have. 16 Α. 17 And when you testified for Monsanto, I believe Q. March 11th in San Francisco, right? 18 I'd have to look at the document to assure you 19 Α. 20 of the date. MILLER: 5 Now, there are scientists in the world of 6 Q. non-Hodgkin's lymphoma who research the issue of 7 pesticides and non-Hodgkin's lymphoma. That's fair, 8 isn't it? 9 Yes, it is. 10 Α. And in your 48 years, you have never 11 0. researched the relationship between pesticides and 12 13 non-Hodgkin's lymphoma. That's --14 Α. 15 Right, ma'am? Q. That is correct. 16 Α. 17 Q. I didn't want to interrupt you. So in 48 years, you've never published 18 anything on the relationship between pesticides and 19 non-Hodgkin's lymphoma. That's also true. 20 That is correct. 21 Α. All right. So you've never done any bench 22 Q. 23 work on the issue of Roundup and non-Hodgkin's lymphoma? That is correct. 24 A. And you never published anything on the issue 25 Q. 5098

1 of Roundup and non-Hodgkin's lymphoma? 2 Α. That's correct. 3 **Q**. Okay. You mentioned Dr. Weisenburger is an excellent physician there at the same hospital, City of 4 Hope. 5 I mentioned he was an excellent pathologist --6 Α. and he is -- at the City of Hope. 7 And I think he thinks highly of you as well. 8 ο. It's interesting. We have two very good physicians, 9 both at City of Hope hospital, right? 10 11 A. Correct. Who have come to, frankly, different 12 Q. conclusions on whether or not Roundup was a substantial 13 contributing factor in causing Mr. Pilliod's 14 15 non-Hodgkin's lymphoma? We have different opinions, correct. 16 Α. 17 Yes. And I think it's good for the whole Q. We can disagree without being disagreeable, 18 country. can't we? 19 That's nice. 20 Α. Yes. In fairness, between the two of you, if the 21 Q. jury was like, hmm, which one has more experience with 22 23 pesticides and its relationship to non-Hodgkin's lymphoma, the truth is it would be Dr. Weisenburger? 24 MR. ISMAIL: Objection, Your Honor. 25 5099

THE COURT: Counsel, let's just stick with 1 2 qualifications to render any opinion, and then we'll 3 talk later about whether or not you want to challenge the opinion and on what basis. 4 MR. MILLER: All right. Very well. 5 BY MR. MILLER: 6 But just to close up that topic, then, you do 7 ο. not consider yourself an expert in the relationship of 8 pesticides and non-Hodgkin's lymphoma, having not 9 researched it for the last 48 years? 10 I do not consider myself an expert on 11 A. pesticides. On the other hand, I've read a great deal 12 13 of scientific data about pesticides and the relationship to lymphoma. 14 15 Since Monsanto hired you? Q. Α. Since Monsanto hired me and a bit before as 16 17 well. Can you name one article that you read before? 18 **Q**. I would have to think and go back into my list 19 A. 20 of articles -- or my files. I can't list you an article 21 right now. All right. You're not a toxicologist, right? 22 Q. 23 I'm not a toxicologist. Α. And there is, within the field of medicine, 24 0. something called infectious disease specialists, right? 25 5100

Α. That is true. 1 And they can get boarded in that specialty, 2 ο. 3 right? That's true. 4 Α. And you're not a boarded specialist in 5 Q. 6 infectious disease, right? I'm not a boarded specialist in infectious 7 Α. disease, but I am deeply experienced in the care of 8 patients with all kinds of infections. Patients with 9 cancer have an increased risk of infections, all kinds 10 of regular infections, all kinds of what is called 11 opportunistic infections, such as those that occur in 12 13 HIV. So I am not board-certified in infectious 14 15 disease; I know a good deal and have had a massive experience in dealing with patients who have all kinds 16 17 of infectious diseases. And that's fair. HIV and AIDS is an 18 0. 19 infectious process, right? 20 A. Yes, it is. And you've spent a lot of your life studying 21 ο. those areas, right? 22 23 I did. And one of the things that the AIDS A. patients get are all of these various infections, which 24 come to my attention because I have to take care of 25 5101 1 patients who have them.

2	Q. And you're not an epidemiologist, right?
3	A. No, I'm not an epidemiologist, but I have
4	spent a tremendous amount of my scientific time looking
5	at epidemiology. My colleagues have been
6	epidemiologists. My papers have dealt with epidemiology
7	of lymphoma, what causes lymphoma, based initially on
8	data, on population base, what is happening
9	epidemiologically.
10	So I'm not an expert, but I have spent 40
11	years in dealing with epidemiology and how it relates to
12	non-Hodgkin's lymphoma.
13	Q. The last time you testified, you didn't want
14	to testify about epidemiology for Monsanto, right?
15	MR. ISMAIL: Objection, Your Honor.
16	THE COURT: Sustained.
17	MR. MILLER: All right. We'll go back to that
18	later.
19	BY MR. MILLER:
20	Q. Now, you have, you told us, about 325
21	publications on your CV?
22	A. Correct.
23	Q. About 200 of them deal with AIDS, right?
24	A. I'd have to count them. Many of them do.
25	Q. And both of your books deal with AIDS-related

1 cancers?

2 They do. Α. 3 **Q**. Okay. Of your 12 internet publications on your CV, we counted 11 of them dealt with AIDS and HIV. 4 Α. I'd have to count them to assure that that is 5 6 true, but I will accept that. And I think we can probably agree, Doctor, 7 **Q**. skin cancer, for the skin, there is a specialty called 8 9 dermatology? That is correct. 10 Α. And you don't hold yourself out as a 11 **Q**. dermatologist? 12 No, I don't, but patients with cancer, 13 A. patients with HIV as well, develop all kinds of problems 14 with their skin. I am well versed in dealing with 15 problems with the skin and cancers of the skin. 16 17 Q. And I looked at your CV last night. Of your 325 articles in your CV, none of them dealt with skin 18 cancer, right? 19 20 Α. That is correct. Not an area of specialty of yours? 21 Q. It is not my specialty; it is non-Hodgkin's 22 A. 23 lymphoma. You had 249 book chapters, which is, again, 24 0. very impressive. 170 of them dealt with AIDS and HIV, 25 5103

right? 1 2 I have 70 book chapters. Α. 3 **Q**. Oh, excuse me. All right. And how many of them deal with AIDS and HIV? 4 Α. I'd have to count. I just don't know. If you 5 want to give me the CV, I can count them for you. 6 Well, how about this. How about we just agree 7 0. that a significant number of them deal with HIV and 8 9 AIDS? 10 A. That's probably true. Okay. And you were first retained by Monsanto 11 **Q**. 12 when, ma'am? It was around November -- October or November 13 Α. of 2018. 14 You wrote your first report for Monsanto on 15 Q. 16 November 26th. Does that ring a bell? I would have to look at the date, but I will 17 Α. accept that for the moment. 18 19 It was not this case, another case --Q. 20 A. Yes. So you must have been working for them for a 21 Q. few months before then. 22 23 I'm not sure. I need the dates, and then I A. can tell you exactly when I started. And I can go into 24 my book and my calendar as well. 25 5104

And you wrote a report in that case, and we'll 1 Q. talk about that more later. And then you've done this 2 3 case. Do you have a third case coming up soon? 4 MR. ISMAIL: Objection, Your Honor. 5 THE COURT: Sustained. 6 MR. MILLER: We'll talk about it later. 7 THE COURT: Qualifications. 8 9 MR. MILLER: Well, we talked about money on 10 the direct. I was just going to --BY MR. MILLER: 11 So you have 500 an hour on this case and 500 12 0. an hour on the other case as well? 13 That's correct. 14 Α. 15 Do you want to tell us how much you've earned ο. so far for the two cases? 16 I don't know about this case. The other case, 17 Α. it was probably about \$80,000. 18 Okay. And that money goes to you; it doesn't 19 Q. go to City of Hope, right? 20 That is correct. 21 Α. Okay. I think you told us you semi-retired at 22 Q. 23 the end of 2016? I retired from my administrative jobs but 24 A. continued my clinical work. 25 5105

Now, when you were first hired and went to 1 Q. 2 work for Monsanto, as late as March, when you testified in that first proceeding, you didn't know Roundup was a 3 pesticide. 4 Do you remember that? 5 6 Do you want to show me what you were referring A. to? 7 Sure. 1654 from Hardeman. And we have copies 8 ο. 9 if you want. THE REPORTER: Counsel, did you say Hardeman? 10 MR. ISMAIL: Objection, Your Honor. 11 12 **THE COURT:** Counsel, approach. 13 (Sidebar discussion not reported.) BY MR. MILLER: 14 Doctor, this is from a proceeding on 15 ο. March 11th, 2019. And we're at page 1654. And I'm 16 17 starting at line 7. THE COURT: No. Allow her to refresh her 18 recollection --19 20 MR. MILLER: Absolutely. **THE COURT:** -- and ask her the question. 21 Do not read from the transcript. 22 23 **MR. MILLER:** I understand, Your Honor. Thank 24 you. 25 THE COURT: Okay. 5106

1 BY MR. MILLER: If you'd read, please, from line 7 through 2 ο. 3 line 11, the questions you were asked and the answers 4 you gave. Does that refresh your recollection that you 5 did not know Roundup was a pesticide on March 11th? 6 Yes. It clarifies my language. 7 Α. 8 Q. Okay. 9 Do you want me to read it? Α. THE COURT: 10 No. BY MR. MILLER: 11 I don't think the Court does. Thank you. 12 ο. 13 But you do know now that Roundup is a pesticide? 14 Roundup is an herbicide. Herbicides are under 15 A. the classification of pesticides, so it's really both. 16 17 MR. MILLER: You can keep that up there. I might be using that later. 18 Let me just look and see if I'm done here. 19 BY MR. MILLER: 20 21 Ο. So that was March 11th. You wrote your report in this case in January, the case we're on here today, 22 23 right? I'll look at the date. If you can give me a 24 A. copy of my report, I can tell you what the date was. 25 5107

Here it is. The date is not listed. 1 2 Do you have a copy that says the date on it? I'm just going to approach with the 3 I do. Q. Court's permission. I'm going to have a copy for you 4 later. 5 6 I'm so sorry. It's on the last page. It was A. written January 24th -- it was signed off, final, 7 January 24th of 2019. 8 MR. MILLER: Subject to the points raised, I 9 10 don't object to the doctor as an expert in non-Hodgkin's lymphoma; but, as to its relationship to pesticides, I 11 do object. 12 Okay. 13 THE COURT: Overruled. 14 You may resume. 15 Thank you, Your Honor. MR. ISMAIL: 16 DIRECT EXAMINATION (resumed) 17 BY MR. ISMAIL: So, Dr. Levine, I want to give an overview for 18 Q. the jury about the topics we're going to cover and just 19 20 sort of give the headline of your opinions, and then 21 we're going to go back and explain how you got there. Okay? 22 23 Α. Sure. So are we showing here a summary of what we're 24 0. going to talk about today? 25 5108

Yes, we are. 1 A. 2 And did you look at Mr. Pilliod's medical ο. records to identify whether he has any risk factors for 3 the development of his diffuse large B-cell lymphoma? 4 Yes, I did. Α. 5 And did you identify whether he had it? 6 Q. Yes, I did. He had a very prominent risk 7 Α. factor for his non-Hodgkin's lymphoma. 8 9 ο. And what was that? 10 A. That was a fully abnormal immune system, an 11 immune system that was not normal. 12 ο. And was his abnormal immune system, as you identified it, an identifiable risk factor for his 13 non-Hodgkin's lymphoma? 14 15 Perhaps the most important risk factor for A. non-Hodgkin's lymphoma is an abnormal immune system, the 16 17 inability of the immune system to recognize that first cell as cancerous and foreign and get rid of it. 18 Did that increase his risk for developing the 19 ο. 20 condition he eventually received? 21 Α. That would absolutely increase his risk of having developed diffuse large B-cell lymphoma. 22 23 And, Doctor, based on your review of both Q. Mr. Pilliod's records and the other information you 24 described, do you have an opinion as to whether or not 25 5109

1 Roundup played any role in Mr. Pilliod's development of 2 cancer? 3 Α. Yes. The bulk of the data from valid scientific studies indicate that the Roundup did not 4 cause Mr. Pilliod's diffuse large B-cell lymphoma. 5 Q. Now, let's go back and talk about -- you 6 described the immune system and its role in cancer 7 surveillance and protection just generally. And we're 8 9 going to go in and describe some of that more fully. One second, Doctor. 10 So if we can advance the slide. 11 12 Doctor, let's start with a description of non-Hodgkin's lymphoma, and then we're going to get into 13 how it relates to the immune system. 14 15 A. Okay. So if you would, please explain sort of 16 0. 17 generally non-Hodgkin's lymphoma, as you would to a patient or a family member. 18 Non-Hodgkin's lymphoma is actually a cancer of 19 A. 20 the immune system itself. And these can be cancers 21 either of B lymphocytes or T lymphocytes. There are many different components of the immune system, but two 22 23 of those components are B or T lymphocytes. B-cells make a protein called an antibody 24 against the germ, and that's what kills the germ or the 25 5110

1 foreign cancer cell. T lymphocytes directly recognize 2 that germ or cancer cell and directly kill it. 3 So this non-Hodgkin's lymphoma is actually a cancer of these very important components of the immune 4 system itself. But it turns out that non-Hodgkin's 5 6 lymphoma is not one disease at all. At this point, there are over 60 different types of non-Hodgkin's 7 8 lymphoma. 9 And it's really important to understand that because these are different diseases. 10 They have different presentation, the way the patient first comes 11 12 to you. They have different causes. They have 13 different treatments. They have different prognosis, how likely you are to do well or not. 14 These are totally different diseases. 15 16 If you're talking about diffuse large B-cell 17 lymphoma in Mr. Pilliod, you need to talk about diffuse large B-cell. It's not the same as non-Hodgkin's 18 19 lymphoma overall. Usually, these malignancies, the non-Hodgkin's 20 21 lymphoma, begin in the lymph glands. But lymphocytes, B-cells or T-cells, have to be all over the body all the 22 23 time because they're always looking for foreign germs or foreign cells. 24 So those cells travel very quickly into other 25 5111

areas of the body. When they do, that's called 1 metastatic, or spreading, of that cancer. And it's very 2 3 common for lymphoma to spread in that way simply because normal B or T lymphocytes spread in that way and always 4 are moving throughout the body. 5 And if you look at all subtypes of 6 Q. non-Hodgkin's lymphoma, how prevalent or common of a 7 cancer is that? 8 9 It's about 2 to 4 percent of all cancers. Α. It's not the most common, but it's not rare either. 10 And when we talk about how cancer develops, 11 0. let's talk about it from the cellular level. 12 13 A. Okay. Can you help teach us how a cell progresses 14 Q. 15 and -- or what the evolution or journey is to becoming a 16 cancer? 17 Actually, it's a long journey. There are A. several steps that are required to actually get a 18 19 cancer. First of all, one needs something that's 20 called a driver mutation in the DNA, an accident in the 21 DNA of a given B or T lymphocyte in this example. 22 The errors -- there are all kinds of errors that can occur 23 in the DNA, accidents. 24 But your body has a way to deal with that. 25 We 5112

have these DNA repair mechanisms. So you're always 1 2 making little errors in the DNA, and your repair 3 mechanisms take care of that for you. The mutation that occurs that causes a cancer 4 eventually has to be what we call a driver mutation. 5 6 That's very specific. It's not just an abnormality; it's a very specific abnormality, a mutation in the DNA, 7 that is then taken forward into every single cell that 8 9 divides from that cell. So the one cell will divide. Both of them 10 have the same driver mutation. Those two cells divide. 11 Now all four of them have the same driver mutation. 12 So it is a permanent mutation, a very specific mutation in 13 a specific area of the DNA that controls how cells 14 15 divide and how they die. And that driver mutation is going to say to 16 17 that cell, "Divide, divide, divide, and never stop." And it's also going to say to the cell, "And don't die 18 either." 19 20 So first you need a driver mutation. Not any 21 old error, not only any old abnormality, you need a driver mutation. 22 The second thing you need for a real cancer to 23 develop is some problem with the repair mechanism. 24 So the person's ability to repair damage to the DNA has 25 5113 1 been impaired, faulty in some way.

And then the third thing that you need is an 2 3 abnormal immune system. Because even if you have a driver mutation, even if you don't have an ability to 4 repair it, you still have an immune system. 5 And the immune system should see that cell and 6 get rid of it. So, really, you need a very specific 7 driver mutation. You need the inability to correct 8 9 that. And then you need an immune system that was also 10 abnormal and unable to recognize that abnormal cell. So let's make sure that I understand this. 11 0. 12 Is any DNA damage -- is that necessarily a driver mutation? 13 No. A driver mutation is very specific. 14 Α. Ιt 15 is a mutation that is hereditable. It passes on through all the generations of those cells. It doesn't die, 16 17 doesn't cause death of the cell. And specifically says to the cell, "Divide, divide, divide, and do not 18 die." 19 20 Q. Are there mutations that can occur even if 21 they're passed on to daughter cells that are not one of these driver mutations that is necessary for the 22 development of cancer? 23 24 Α. Would you repeat that? I'm not sure. 25 Sure. 0.

5114

Are there other mutations that are not driver 1 2 mutations? 3 Α. Yes, there are. What do we call those in medicine? 4 ο. They're called passenger mutations. It's kind 5 Α. of interesting, because 90 to 99 percent of all of the 6 mutations are really passenger. They're irrelevant. 7 They don't really matter to the person or to that cell. 8 9 So it's a very specific kind of mutation that will eventually lead to cancer if those other factors 10 11 are present as well. Does glyphosate, or Roundup, cause mutations? 12 0. 13 A. No study has shown that glyphosate causes mutations in those cells. 14 15 And you said the second part -- and we're ο. 16 going to talk about that a bit this morning -- is, for a 17 cancer to develop, the immune system failed in some way to detect or destroy that cancer; is that correct? 18 That is correct. 19 Α. 20 Q. Now, the jury has heard this term 21 "genotoxicity." Obviously, you've heard that in your 40-plus years as an oncologist? 22 23 Yes, I have. Α. Is genotoxicity the same thing as cancer? 24 0. Genotoxicity is a nonspecific word. 25 No. Α. Ιt 5115

1 just means some abnormality at that DNA, some problem. 2 But it doesn't mean anything more than that. 3 And did you help us put together this 0. explanation, and can you tell us what you're 4 communicating here with this slide? 5 I just wanted to explain what 6 A. Yes. genotoxicity really meant. 7 And, again, it's a very nonspecific term. 8 It 9 just means any kind of DNA damage. It is not -- it 10 doesn't mean driver mutation, by any means. So it's a 11 nonspecific term. It is not the same as a mutation, and it's not the same as a driver mutation. 12 13 So you have some examples that you put here, 0. double-strand breaks or single-strand breaks. 14 15 What are those examples of? 16 Α. Those are examples of nonspecific DNA damage. 17 We get one bit of our DNA, half from your mother and half from your father. So one strand from your mother, 18 one strand from the father. And both strands could 19 20 break, a single strand could break. That's what it 21 means. And those are nonspecific examples of DNA 22 damage. 23 And does double-strand break or single-strand 0. 24 break, does that mean the same thing as a mutation or a driver mutation? 25 5116

No, it doesn't. 1 A. Now, we have -- the next bullet you put here 2 0. 3 were tests. And these are some tests that the jury may have seen earlier in this trial. 4 Do those tests that are described here testing 5 for mutations? 6 Those tests -- comet assays and 7 Α. No. binucleated micronuclei -- big words -- those are not 8 tests of mutations at all; those are tests of 9 10 nonspecific genotoxicity. 11 Now, the jury has heard about a couple of 0. studies that involve aerial spraying of formulated 12 13 glyphosate in areas of Ecuador, the border of Ecuador, I believe? 14 15 Yes. A. 16 ο. And the study authors were Paz-y-Mino and 17 Bolognesi. Have you read those articles as well? 18 Yes, I have. 19 Α. 20 0. And the jury has seen them several times. 21 We're not going to walk through them yet again. But, in your review and opinion, Doctor, do they show that 22 formulated glyphosate causes driver mutations, first of 23 all? 24 Neither of those studies show that glyphosate 25 Α. 5117

causes driver mutations. They do not show that. 1 Can you even read those articles to conclude 2 0. 3 that glyphosate-based formulations cause specific qenetic damage? 4 The papers were interesting to me. 5 Α. The 6 Bolognesi article was careful to look at individuals who were exposed to glyphosate and those who were not 7 exposed. And there was no difference at all in these 8 9 nonspecific changes that they described between those 10 who were exposed and those who were not exposed to glyphosate.; i.e., it did not show me that the 11 12 patients -- the individuals in the city -- one was in 13 Columbia -- the Bolognesi was in Columbia. The other, Paz-y-Mino, was in Ecuador, I believe -- so the 14 15 populations there. And in the Paz-y-Mino study, after the initial 16 0. 17 tests, did those researchers go back to those communities and do additional genetic testing of the 18 citizens there? 19 20 Α. Their first testing was done somewhere between 21 two weeks and two months from the time that the spraying was done. We have no idea what else those individuals 22 23 might have been exposed to during those two weeks to two It did not show statistical evidence of any 24 months. chromosomal mutations, no mutations, and no nonspecific 25

5118

DNA damage. When they went back two years later, there 1 was nothing there at all. 2 3 **Q**. So have you also heard the term "oxidative stress"? 4 Yes, I have. 5 Α. Is oxidative stress the same thing as cancer? 6 Q. No, oxidative stress is not the same thing as 7 Α. 8 cancer. 9 ο. Is oxidative stress even the same thing as mutation? 10 No, oxidative stress is not the same thing as 11 Α. a mutation. 12 Is oxidative stress something that is 13 **Q**. happening in our bodies even without exposure to any 14 chemicals? 15 16 Α. Yes. We're always making these oxygen 17 radicals, they're called, and we have mechanisms to suppress them, to get rid of them. And there's a 18 19 balance of what we make and what we destroy. 20 It's happening all the time in our bodies. 21 When you have a cold, the oxygen radicals will go up. When you run a marathon, the oxygen radicals will go up. 22 23 So it happens quite commonly in all of us. Does that mean having a cold causes cancer? 24 0. No, having a cold does not cause cancer, 25 A. 5119 1 thankfully.

2	Q. So can oxidative stress lead to genotoxicity?
3	A. Yes, it can lead to nonspecific DNA damage.
4	Q. As you described for us, is that the same
5	thing as having one of these important necessary
6	mutations that is part of cancer development?
7	A. It is not at all the same thing.
8	Q. And now I just want to sort of summarize this
9	part of your testimony here, Doctor.
10	So with respect to these concepts of
11	genotoxicity and oxidative stress, is genotoxicity
12	cancer?
13	A. No, it is not.
14	Q. Is genotoxicity the same thing as a driver
15	mutation?
16	A. No, it is not.
17	Q. Is oxidative stress cancer?
18	A. No, it is not.
19	Q. And is oxidative stress the same thing as a
20	driver mutation?
21	A. No, it is not.
22	Q. You described that the necessary step in
23	cancer development is this important mutation.
24	Do you need to have exposure to something like
25	a chemical for one of these driver mutations to occur?
	5120

1 2 A. No, not at all.

Q. And can you explain why that is.

3 Maybe I'll use an example with Mr. Pilliod. A. Mr. Pilliod had something called ulcerative colitis, and 4 that means that his immune system is abnormal and sees 5 his own colon cells, his own qut cells, as foreign to 6 And because of that, his own cells are trying to 7 him. knock off his own internal colon cells all of the time. 8 9 That's all internal. He doesn't need any other external force to allow this to occur. His immune system is 10 seeing something foreign all the time and reacting 11 12 aqainst it.

Q. And as those lymphocytes react to that inflammation or, in his case, inability to recognize his own tissue as cell for foreign, what are the lymphocytes doing as they're stimulating?

A. So as those lymphocytes are stimulated all the
time, they're dividing over and over and over. And as
they divide over and over, every time they have the
opportunity for an error to occur, in that, before the
cell can divide, the DNA, the whole DNA has to divide.

And if those cells are dividing over and over and over again, there is an increased chance that there will be an error at that DNA as it's tying to divide itself, and one of those errors could certainly be a driver mutation.

Q. This process of stimulation of the lymphocytes
in response to either an autoimmune disease or a virus,
does that have a name?

A. It's called chronic antigenic stimulation. So
something foreign to you would be an antigen, a foreign
protein, something foreign.

8 So chronic stimulation by something -- an 9 abnormal protein, something foreign to you -- allows 10 those lymphocytes, forces the normal ones to divide over 11 and over to try to knock off that foreign thing, be it 12 your own cell or be it another.

13 Q. This concept of product antigen stimulation 14 that you've told us about, is this something that you 15 teach medical students and something that you've looked 16 at yourself outside this courtroom?

17 Yes, I have. It is well known, for example, A. that inflammation is one of the risk factors related to 18 19 non-Hodgkin's lymphoma. Chronic antigenic stimulation 20 is anything internal or external that will cause those immune cells, B- and C-cells, to divide over and over, 21 makes them divide over and over and increases the risk 22 that a mutation, a true driver mutation, could occur. 23 24

Q. So thus far, Doctor, you've talked about the first side of the equation, the necessary step of a

1 mutation.

2 You also mentioned that the immune system is 3 also part of this development of cancer. I want to turn to that discussion now. 4 5 Α. Okay. Okay. So when you -- before I get to the 6 Q. picture, let's just talk about the immune system 7 generally. 8 I think everyone has a general understanding 9 10 of what the immune system is supposed to do, but can you talk to us about what the cells are in the body that go 11 12 about identifying foreign cells and their response to it? 13 Excuse me, Mr. Ismail. 14 THE COURT: We have to 15 take a morning break. So maybe before you launch into your next topic, we'll take a ten-minute break. 16 17 All right, ladies and gentlemen. We're going to take a break for ten minutes. We'll come back at 25 18 of the hour and resume. Thank you. 19 (Recess taken from 10:25 a.m. to 10:40 a.m.) 20 21 (The following proceedings were heard out of the presence of the jury:) 22 23 MR. EVANS: Your Honor, I believe what was raised at sidebar, Mr. Miller, both with Dr. Mucci when 24 examining her, referenced the, quote, Johnson case and 25 5123

1 her prior testimony in the Johnson case. And we 2 objected and said you should not use the name of prior testimony in prior trials. And then this morning he did 3 the same thing with this witness with the Hardeman case. 4 And they obviously are trying to tie both 5 witnesses to prior trials that the jury has heard about. 6 We know that from voir dire. And we think it's 7 completely improper, prejudicial, violates motions in 8 9 limine exactly on this that Your Honor has ordered, and we believe it is subject to and should result in a 10 mistrial. 11 12 MR. WISNER: Your Honor --13 MR. MILLER: Let me respond. MR. WISNER: Get the witness. 14 15 THE COURT: You may step down, Dr. Levine. Thank you, Dr. Levine. 16 17 MR. MILLER: Your Honor, it was very clear, and we agreed the last with Dr. Mucci, don't say the 18 19 word "trial" anymore. THE COURT: No, don't say the word "trial" or 20 21 Hardeman or whatever. MR. MILLER: I haven't since, Your Honor, 22 23 I have not said the word Hardeman. sidebar. 24 THE COURT: I know. But you weren't supposed to say it in the first place. 25 5124

MR. MILLER: Well, I apologize, but I thought 1 the admonition was to not say "trial." 2 3 THE COURT: No. But you know the admonition was to not reference those particular trials. I mean, I 4 was very clear about not only trials, but you were only 5 supposed to obliquely reference to prior proceedings. 6 MR. MILLER: I have to be very -- I can't --7 **THE COURT:** You can't mention a prior trial 8 9 that has taken place. Come on. You know I've said that 10 more than once. MR. MILLER: I understand, Your Honor. And I 11 want to follow the Court's instructions. That's why 12 13 I've been able to say -- have the privilege of practicing law for 40 years. I truly want to follow the 14 Court's instructions. 15 I thought we agreed don't mention the word 16 17 "trial." Now, at sidebar, Your Honor said -- and I've been following it since sidebar -- don't mention 18 Mr. Hardeman's name. But I have to use the testimony 19 20 from -- I'll call it a proceeding; I'll call it a 21 sworn -- whatever the Court wants me to call it is what I'm going to call it. 22 THE COURT: I was fine with "proceeding." 23 Ι said that last Thursday or Wednesday or Tuesday. I just 24 have to remind you because, really, the objection was do 25 5125

not specifically reference the trials by name. So we 1 came up with "proceeding" so it doesn't actually 2 3 reference trial. MR. EVANS: And the date. 4 **THE COURT:** But the issue we talked about was 5 you can't say Johnson, you can't say Hardeman because it 6 does bring up trials that they are aware of. 7 So "proceeding" was secondary to not mentioning 8 9 specifically the Johnson trial, the Hardeman trial, 10 which all of the jurors are aware of. 11 **MR. MILLER:** I understand. And that's the way 12 we're going to do it. MR. WISNER: Your Honor, just to clarify for 13 the record, though, Mr. Miller specifically said the 14 15 proceeding in March. She said, "What are you talking about?" He gave her the date. She still was confused. 16 17 THE COURT: Well, let her be confused. But don't mention --18 **MR. WISNER:** No, I understand. 19 I'm just 20 saying. And he then said it was a proceeding in 21 San Francisco. She again didn't understand, and he went to the Hardeman case, hoping that would refresh her 22 recollection. It won't happen again, but the witness 23 really drew that out. It wasn't Mr. Miller trying --24 THE COURT: You're all skilled, very skilled. 25

5126
You know how to figure that out, including having the 1 2 jurors leave if you need to have them leave so that 3 they're unaware of what's going on. That's fine too. But no more Johnson, no more Hardeman. 4 Absolutely. Mistrial denied, but -- we're at the end. 5 6 Let's get there. MR. MILLER: I understand. 7 MR. WISNER: Yes, Your Honor. 8 9 THE COURT: Let's just get there. 10 All right. We've going to have the jurors come back in. 11 12 (The following proceedings were heard in the 13 presence of the jury:) MR. ISMAIL: May I proceed, Your Honor? 14 15 THE COURT: You may. 16 MR. ISMAIL: Thank you. 17 BY MR. ISMAIL: Dr. Levine, I had just two quick follow-up 18 Q. 19 questions for you before we turn to the subject of the 20 immune system. You mentioned that you were -- your clinical 21 and research interest was piqued back in the early '80s 22 when you saw this sort of unusual presentation of 23 lymphomas in your clinical practice, and you described 24 then your work to understand and help with that AIDS 25 5127 1 epidemic crisis.

2 What was it about the presentation of those 3 early patients before you even had a name for the condition that prompted your interest? 4 There were several things. First of all, 5 Α. lymphoma usually occurs in people who are older, in 6 their 60s and so forth, and these people coming in were 7 young men. And right away, that got my attention. 8 9 The second was that the lymphomas were widely 10 disseminated, involving many, many, many organs in the body, widely disseminated. 11 I guess the next thing was it wasn't just that 12 they had the lymphomas, these unusual, widely 13 disseminated, fast-growing lymphomas; but they also had 14 all kinds of interesting or difficult infections at the 15 same time. 16 17 So it was all of those things that said to me what is this? Something is different here. 18 19 ο. Did the presentation of these patients with 20 these infections on top of the lymphomas or concurrent 21 with the lymphomas connect with your training in oncology that there might be an immune-related 22 connection between what you were seeing? 23 24 A. Yes. MR. MILLER: Your Honor, I would object. 25

1 Leading.

2	THE COURT: Overruled.
3	Go ahead. Finish your answer.
4	THE WITNESS: Yes. The infections and no real
5	control over those lymphomas spreading so quickly and
6	rapidly said to me is there something wrong with the
7	immune system of these people? And I started to look at
8	it.
9	BY MR. ISMAIL:
10	Q. Now, the second question I wanted to ask you
11	from a prior discussion relates to this concept of
12	driver mutations that you told us about.
13	And you told us well, let me ask it this
14	way: Does showing genotoxicity, can that does that
15	genotoxicity in a cell become a driver mutation?
16	A. No. The abnormality in the cell is a driver
17	mutation or something else. One error doesn't lead to
18	the other. One accident or aberration doesn't lead to a
19	driver mutation. The mutation occurred or it didn't.
20	Q. So if you can't if all you're showing is
21	genotoxicity generally but not mutations specifically,
22	are you demonstrating the ability of some chemical to
23	cause cancer?
24	A. Not really, no.
25	Q. Now, continuing to where I was right before
	E130

1 the break, we were just getting started about the immune 2 system. 3 Can you just generally describe how the immune system works with respect to detecting and protecting us 4 from foreign cells in our body. 5 So, first of all, the immune system is 6 A. comprised of many, many different cells: 7 The lymphocytes that we talked about, T lymphocytes, 8 9 B lymphocytes. There are cells called macrophages, monocytes, dendritic cells, neutrophils, eosinophils, 10 There are many, many different components of 11 basophils. 12 the immune system. And they work in concert, each doing 13 the job in another different kind of way, a little different way, to try to keep us safe from these foreign 14 15 invaders. And, Dr. Levine, have you used pictures of 16 ο. 17 these immune system cells and their role and function when you are teaching medical students or other 18 audiences? 19 20 A. Yes, I frequently use them. 21 And have you brought some of those with you ο. today to help teach us about the immune system? 22 23 I did. Α. So the first picture we have here, can you 24 Q. describe what's going on? Well, first of all, how is 25 5130 1 this picture even taken?

2 It's called an electron microscope. So it's a Α. 3 way to go way down on the cell level and actually see deeply into the cell when a regular microscope could not 4 see that. And then stains are applied to show the 5 different colors. 6 This isn't a drawing or a cartoon; this is 7 Ο. actually a photo? 8 9 Α. This is a photograph taken from an electron 10 micrograph. Can you tell us what you're showing here? 11 0. First of all, the green cell is something 12 Α. called a macrophage, and that's part of the immune 13 system, one of those cells that's important. 14 And what 15 you see in orange are literally TB germs. Are those tuberculosis germs? 16 ο. 17 I'm sorry. Tuberculosis. Correct. Α. 18 So what you're seeing is the macrophage has recognized these cells as being foreign. It's now 19 20 literally eating them; it's engulfing them. And once it 21 does, it will, quote, digest them. It will use all kinds of chemicals to kill that TB. 22 23 Right now we have drugs for TB. We use them. But prior to the time that we had medicines to treat TB, 24 lots of people had it, but not everyone dies of TB. 25 And

1 the reason is we have an immune system, and the immune 2 system is supposed to do that for us, and very often it 3 does. So this is just an example of one cell in the immune system recognizing a germ, a foreign germ as 4 foreign, and killing it. 5 Is a cancer cell a foreign cell that the body 6 Q. should recognize and protect us from? 7 That is exactly the point. A cancer 8 Α. Yes. 9 cell is foreign to you and should be seen as foreign to 10 you by that immune system. Should be able to see it, recognize it, attach to it, and kill it. 11 Now, are these also photographs of the immune 12 ο. 13 system working properly to identify a foreign cell? Yes. And this is another example, something 14 Α. called a natural killer cell, another part of that 15 16 immune system. 17 And the cancer cell is the one in yellow. The natural killer cell is in that grayish-blue color. 18 And you see, first of all, it's attaching, parts of it are 19 20 actually attaching to that cancer cell. They recognize 21 They see that it's foreign, and they're attaching it. to it. And as soon as they attach to it, they literally 22 are poking a hole in that cancer cell, and it just 23 It dies. 24 explodes. So that's an example of a cancer cell being 25

seen as foreign and being destroyed by the immune 1 2 system. 3 **Q**. Is this another photograph to help explain the concept of the role of the immune system in detecting 4 foreign cells? 5 Yes. So what we're seeing here in the 6 A. middle -- what you see in the middle is a dendritic 7 cell, something called an activated dendritic cell, 8 activated because it's seeing something as foreign to 9 10 it. And what it's doing here is relaying its 11 This is what foreign looks like to a T-cell. 12 message. 13 So they're working in concert. The two kinds of cells are working together, one to recognize and say this is 14 15 the foreign one; this is the one you better get rid of. 16 Now the T-cell has that message, and now the 17 T-cell is going to go forward to do something to that foreign cell. 18 And so if a patient has an abnormality in any 19 ο. 20 one of these processes, might that affect the patient's 21 ability to identify and protect that patient from cancer cells? 22 So you don't need all of your immune 23 Yes. Α. system to be gone to get in trouble here. You just need 24 one or another of these elements of the immune system to 25 5133 1 be abnormal.

2	Q. So is it simply a question of measuring T-cell
3	count in a patient to determine whether their immune
4	system is functioning properly or not?
5	A. Well, first of all, T-cells are one part of
6	the immune system, and an important part; I don't deny.
7	On the other hand, there are other parts of the immune
8	system.
9	And, number one, you want each of these parts
10	to be the right number. You know, if you didn't have
11	any of these cells, you'd be in trouble. But even if
12	you have the right number, they have to be functioning
13	normally. They have to be working normally.
14	So the number is nice. But once you have a
15	number, now you have to know do those cells actually
16	work on not?
17	Q. So earlier in the trial, Dr. Nabhan was here
18	talking with the jury, and he referenced that
19	Mr. Pilliod had his T-cell count assessed at some point
20	in time.
21	Is that T-cell count is that the only thing
22	you have to consider when assessing whether Mr. Pilliod,
23	in particular, immune system was operating normally?
24	A. No. First of all, the T-cells I did see
25	that in his records, and the number of his T-cells were

normal, but there was no test done to look at the 1 2 I believe that his immune system is clearly function. 3 abnormal, and there are many, many different cells that compromise that immune system. 4 And we'll show the reasons why you've arrived 5 Q. at that conclusion with respect to the immune system. 6 What are you depicting here in this next 7 photograph? 8 9 Α. I'm showing the T-cell now had that message, 10 what is foreign? And in this example, the foreign was the cancer cell, and the big brown thing there is a 11 cancer cell. And what you see is the T-cells are now --12 13 they are armed with a message. They know what foreign Foreign has told them that is the cancer cell. 14 is. They are attaching to the cancer cell, and they will 15 kill that cancer cell. 16 17 And if there's some malfunction in this Q. process, either messaging or functioning of these cells, 18 will that put that patient at increased risk of 19 20 developing non-Hodgkin's lymphoma? Those T-cells could be normal in number 21 Α. Sure. but not functioning. 22 23 Now, has this concept of the immune system Q. playing an important role in cancer risk resulted in new 24 25 therapies that researchers are coming up with to treat 5135

these cancers? 1

2	A. Yes. This is one of the most exciting times
3	in all of oncology. We're using the immune system is
4	so powerful in preventing cancer in us and recognizing
5	this and preventing it, the next question was can we use
6	the immune system to treat cancer? Can we develop we
7	call them immunotherapies. And they're in the
8	newspapers. I don't know if you've read.
9	But, in any event, one of those first
10	immunotherapies, arming the immune system to fight the
11	person's cancer, is something called CAR T-cells,
12	chimeric antigen receptor. It's a big word; doesn't
13	matter. But anyway, they are T-cells that we
14	genetically modulate, engineer, to recognize diffuse
15	large B-cell lymphoma.
16	And, as it turns out, there are two products
17	that are licensed in the United States right now to
18	treat diffuse large B-cell lymphoma, and these are CAR
19	T-cells. They work. The T-cells, if they're working
20	properly, or if we can give the patient T-cells that
21	work properly, are remarkably effective. I can't tell
22	you how exciting it is. This is remarkably effective.
23	And what you see here is the genetically
24	engineered cell, the CAR T-cell directly attaching.
25	Again, it points an attachment. It sees. And once it
	5136

sees, again, it will destroy that cell and has been able 1 to provide survival in about 50 to 60 percent of 2 3 patients who had no treatment more available to them at all with diffuse large B-cell lymphoma. 4 Does the success of these immune-based 5 Q. 6 therapies in cancer treatment speak to the importance of the immune system in protecting us all from cancer? 7 That is exactly the fact. And the reason that 8 Α. 9 abnormal immune system is so prominent as a risk factor 10 for non-Hodgkin's lymphoma is simply that fact. Now, there's a therapy called rituximab --11 0. Correct. 12 Α. -- that has actually been referenced earlier 13 0. in this trial. 14 15 Did Mr. Pilliod receive rituximab as part of 16 his cancer treatment? 17 Yes, he did. It was part of his -- what's A. called the R-CHOP regimen, and the R was rituximab. 18 19 Q. Can you tell us what you're showing here with 20 this drawing? 21 What I'm showing is the cancer cell looks Α. different from other kinds of cells. In this example, 22 the lymphoma cell has a protein on its surface. 23 It's called CD20. 24 25 And what we have is an antibody. Here's 5137

what -- a B-cell would make an antibody to kill that 1 2 foreign germ. So here we have an antibody to CD20. 3 Biology works by a lock and a key. One chemical fits into the other. And as soon as that happens, something 4 happens. But it starts with recognizing a fit, a lock 5 and a key. 6 So if the lock is the rituximab antibody, it 7 was designed, it was developed, engineered so that it's 8 9 a perfect fit to the CD20 on the non-Hodgkin's lymphoma 10 cell. Mr. Pilliod's lymphoma was CD20 positive. 11 He was given the antibody. And what you can see is the 12 attachment. Right away, it's going to attach into that 13 lock and a key. And once it does that, by different 14 mechanisms that I don't have to go into unless you want 15 me to, the cell will die. By ADCC, by -- there are 16 17 different mechanisms. The cell will die. Is this a form of immunotherapy? 18 **Q**. 19 A. It is a form of immunotherapy and has changed 20 the prognosis in diffuse large B-cell lymphoma 21 appreciably since that antibody was developed and used. Is this rituximab therapy that was used in 22 Q. Mr. Pilliod's case, was it effective as part of his 23 other cancer treatments in allowing him to get into 24 remission a few months after he was diagnosed? 25 5138

This was a major component of the 1 A. Yes. success of the therapy that was used. And it was 2 3 successful therapy with Mr. Pilliod, which is really 4 qood. Now, I want to talk further about Mr. Pilliod 5 **Q**. and his medical history. 6 But, just generally, why do oncologists go 7 about getting a patient's past medical history when they 8 9 are newly diagnosed with cancer? 10 A. There are multiple different risk factors for There are multiple points in a history that 11 lymphoma. might help me, guide me a little bit to know how I need 12 13 to treat that patient or what special concerns I must be attentive to. 14 15 So I need to know the entirety of what is that 16 medical history. It tells me who the patient is in a 17 certain sense biologically, medically, gives me hints as to how I need to treat, gives me hints perhaps as to 18 diagnosis or what I have to do. 19 So let's just do an overview of Mr. Pilliod's 20 0. 21 medical history. And then we'll talk about how these factors led you to identify which risk factors he had 22 for non-Hodgkin's lymphoma. 23 So if you can just give us an overview, a 24 general picture of Mr. Pilliod's medical history as you 25 5139

saw it from his medical records? 1 First of all, he has had a total of 22 2 Α. 3 different skin cancers. Those began in 1970 when he was in his late 20s. That would be guite unusual to be 4 diagnosed with that many and starting so early in life. 5 Then I saw, in 1978, when he was 36, he had 6 his first episode of infection in the brain. 7 And we call that meningoencephalitis. 8 9 Encephalitis means infection and inflammation 10 in the brain. The meninges are the tissues that cover the brain. So he had an infection of the brain, 11 encephalitis, and of the tissues surrounding the brain. 12 13 They did not know what caused it at that time. 14 They were thinking that it could be autoimmune; i.e., 15 his own immune system saw his brain cells as foreign to him and tried to destroy them, or they thought it might 16 17 be related to a virus of some sort. Did not know what the virus could be, but those were the two things that 18 they were thinking about, something called herpes 19 20 simplex virus and autoimmune. 21 In time, he's had multiple -- he had four other reoccurrences. So he's had five episodes of brain 22 23 infection. This is due to the herpes simplex virus, HSV. 24 HSV, that herpes simplex virus, it causes cold 25 5140

sores and is very, very common. I will assume that 1 almost everybody in this room has had a cold sore every 2 3 once in a while. And that's due to HSV type 1. HSV type 2 can cause sores, the same kind of sores, but 4 in the anogenital region. But most of us certainly have 5 had HSV 1; we have not had infection of the brain on 6 five different occasions caused by the cold sore virus. 7 That said to me, whoa, what is this? What is this? 8 9 That was formally proven to be due to the

10 herpes simplex virus at a time when the spinal fluid was 11 examined and found to have HSV in the spinal fluid. He 12 was treated for HSV. He continues to be treated for 13 HSV.

He then had recurrent genital warts. Now, that's also caused by a virus. It's called human papilloma virus, HPV. Again, this is a relatively common virus in the community in general; but, very often, the most common thing is that your own immune system clears it.

And then to have that herpes simplex virus causing these genital warts at the age of 60 and so forth, that would be very unusual. It was allowed to persist. His immune system did not clear it, as usually occurs.

25

In 2006, he was diagnosed with ulcerative

colitis. That was proven by a biopsy. And that means 1 2 it's an autoimmune disease. His immune system is seeing 3 his own colon tissue as foreign to him and trying to So that was another example to me that, oh, my 4 kill it. gosh, this immune system, this is not normal here. 5 He does have a family history of cancer. And 6 that's associated with the patient himself developing 7 8 cancer. 9 He does have a history of 20-year pack-a-day And then he has other medical conditions, 10 smoker. multiple brain injuries over the years in addition to 11 the infections in his brain. A history of stroke, sleep 12 13 apnea, high blood pressure, something called hemochromatosis, which is congenital, you're born with 14 15 that, and you don't deal with iron normally. So let's break down some of the things you 16 ο. 17 just talked about with the jury. Let's start with skin 18 cancer. 19 Are these the dates and diagnoses and the locations of the skin cancers that Mr. Pilliod has 20 experienced in his adult life? 21 22 Α. Yes. These are. And have you looked at the medical records to 23 Q. 24 identify each one of these diagnoses and the dates and locations? 25

5142

Yes. I didn't have a location. I didn't have 1 Α. records from 1970 to tell me the location. But other 2 than that, yes, we have the pathology reports, the dates 3 where these biopsies were taken, and so forth. 4 And is this an accurate summary, to the best 5 Q. of your ability, of those diagnoses? 6 Yes. And what you see on the left is all of 7 Α. them that occurred before he ever had lymphoma. And, on 8 9 the right side, you see all of those that were diagnosed 10 after he had lymphoma. 11 So rather than go through 22 different sets of Q. medical records, I want to work from this summary here. 12 13 So you said this first skin cancer diagnosis was back in 1970. And how old was he at that time? 14 15 He was 28. Α. 16 Q. Is that an unusually early time to present with skin cancer? 17 Yes, it is. Skin cancer in general is not 18 Α. 19 uncommon; but, at age 28, or many, many, those facts are 20 uncommon. And that was a basal cell carcinoma? 21 ο. 22 A. Correct. 23 Did he have repeated instances of basal cell Q. carcinoma? 24 Yes, he did. He had a total of 16 basal cell 25 Α. 5143 1 carcinomas.

Did he have other forms of skin cancer besides 2 Ο. 3 basal cell carcinoma? Yes. He also had something called squamous 4 A. cell cancer of the skin. 5 Q. Is that a different type of skin cancer? 6 It's a different type of skin cancer, yes. 7 Α. Did he also develop melanoma of the skin? 8 ο. 9 Yes. He developed melanoma, which is a very Α. aggressive kind of skin cancer, far more aggressive than 10 11 these other two. He developed that about a year prior 12 to the diagnosis of lymphoma. 13 **Q**. And you focused on this period the year prior If we look here, the jury has heard 14 to his diagnosis. 15 that Mr. Pilliod was diagnosed in June of 2011. Did Mr. Pilliod develop basal cell carcinoma, 16 17 squamous cell carcinoma, and melanoma within the year before he developed non-Hodgkin's lymphoma? 18 He developed three different kinds of 19 A. Yes. 20 skin cancer before he ever had lymphoma, and about a 21 year before. In total, how many different skin cancers has 22 Q. Mr. Pilliod had in his adult life? 23 So, in total, he's had 22 skin cancers. 24 A. 25 Now, as someone who's been practicing medicine Q. 5144

1 for nearly 50 years, have you ever seen a patient with 2 22 skin cancers? 3 Α. Actually, this would be extremely unusual. Ι really have not seen this before. I haven't really even 4 seen this in my AIDS patients. 5 Now, it has been described to the jury 6 Q. previously that skin cancer is associated with UV light 7 exposure? 8 9 Α. Yes, it is. Is that a risk factor for the development of 10 Q. skin cancer? 11 Yes. An important risk factor for skin cancer 12 Α. is exposure to UV sunlight. 13 And if patients have lighter skin tone, has 14 ο. 15 that also been reported as a risk factor for skin 16 cancer? 17 Α. That is an increased risk factor for Yes. skin cancer. 18 Even given those risk factors, do you find it 19 Q. 20 unusual that a patient would develop skin cancer on 22 separate occasions in their adult life? 21 Yes, I do. That is unusual. 22 Α. 23 And what is this -- what is the relationship, 0. as you see it, between the skin cancers and 24 understanding Mr. Pilliod's risk for developing 25 5145 non-Hodgkin's lymphoma?

1 Well, first of all, just -- let's just talk 2 Α. about the UV light for one moment. 3 UV light clearly is associated with an 4 increased risk of all of these skin cancers. But the 5 6 other interesting thing is that UV light is protective against lymphoma. So it isn't the UV light that's 7 involved here. It's not that. That would have 8 9 protected him from lymphoma. What this means to me is something -- I need 10 to look at his immune system. Something isn't right 11 12 with the immune system. That would be one of my 13 questions right away. Is the immune system part of the process of 14 ο. 15 cancer detection and cancer protection even in the context of skin cancer? 16 17 Oh, yes. Absolutely. Immune system goes A. everywhere in the body. It has to. It has to find 18 germs everywhere or foreign cells everywhere. 19 20 Q. Have researchers looked at the question of 21 whether having recurrent skin cancer is a risk factor for developing non-Hodgkin's lymphoma? 22 23 Yes, they have. Α. 24 0. And have you reviewed that literature for your opinions in this case? 25

A. I did. 1 2 And the jury has seen each one of those 0. articles previously. And so we won't walk through them 3 4 yet again. But can you tell us, Dr. Levine, whether 5 6 you've reviewed this literature and research yourself? Yes, I have. 7 Α. Can you give us an overview of what these 8 ο. 9 studies show with respect to the risk of developing 10 non-Hodgkin's lymphoma in patients with recurrent skin cancer? 11 So the first two articles on your left 12 Α. Yes. talk about basal cell cancer. The next one talks 13 about -- well, okay. 14 The first two talk about skin cancer. 15 Both of 16 them show statistically increased risk of developing 17 lymphoma if you have had basal cell cancer prior. The Cho article talks about the more basal 18 19 cell cancers you have, the more increased risk you have, 20 0, 6, 12, and so forth. The Nugent article talks about when you got 21 those skin cancers. All of these are statistically 22 23 significant, these relationships. They are scientifically valid. 24 So if the basal cell was diagnosed less than a 25 5147

1 year from the lymphoma, or one to four years, again, 2 significantly significant increase in lymphoma in those 3 patients. Nugent also looked at squamous cell cancer. 4 And, again, squamous cell is associated with abnormal 5 6 immune system in general. We can talk about that later if someone wishes. 7 In any event, the squamous cell is 8 9 statistically more likely to be associated with an increased risk of lymphoma if diagnosed less than a year 10 or one to four years before. 11 The Wheless article talks both about basal 12 13 cell and squamous with the exact same data, statistically significant increase in lymphoma in 14 15 patients who have had prior basal cell or prior squamous cell carcinoma. All of these are saying the exact same 16 17 thing. And then we have the melanoma work of 18 Dr. Verner and then Dr. Lens. What we see there is kind 19 20 of interesting. Because, if you have melanoma first, you are statistically more likely to develop lymphoma in 21 22 time. But the opposite is also true. If you develop 23 lymphoma first, you are statistically more likely to 24 develop melanoma over time. 25

In other words, it's going in both directions. 1 2 And when it goes in both directions like that, I, as a clinician or a physician, will think of common cause. 3 It goes in either direction. What's the common cause? 4 So in terms of these various relative risks 5 0. 6 that you have reported here, this one is for basal cell skin cancers of six or more. Does Mr. Pilliod fall in 7 that group? 8 9 Α. Yes, he does. With respect to basal cell skin cancer, did 10 Q. Mr. Pilliod have basal cell skin cancer both one year 11 and one to four years prior to his NHL? 12 Yes, he did. 13 Α. Same with the squamous cell? 14 Q. 15 A. Correct. This is an overall look at nonmelanoma skin 16 ο. 17 cancer. He would fall in these relative risks? He falls within those risks, yes. 18 Α. And then does he fall in both of these with 19 ο. 20 respect to melanoma? Well, he falls -- in other words, first he had 21 Α. melanoma, and then he developed lymphoma. So he falls 22 23 in the first article there. Now, does this research mean that, if you have 24 Q. skin cancer, it causes the patient to develop 25 5149

1	non-Hodgkin's lymphoma? Does the skin cancer turn into
2	lymphoma?
3	A. No. It doesn't cause it at all; it's a risk
4	factor. So it says to the physician be careful here,
5	look for this, be careful for this. But it doesn't
6	cause it at all.
7	Q. Now, have some of these researchers looked to
8	see what the link is in terms of the risk of developing
9	skin cancer and the risk of developing non-Hodgkin's
10	lymphoma?
11	A. Yes, they have.
12	Q. Now, if you turn to Exhibit 6502 in your
13	binder.
14	Is that the Wheless article that we're showing
15	here?
16	A. Yes.
17	Q. Okay.
18	So this has been published previously.
19	And this is a look at the why don't you
20	tell us in a few sentences what this paper is doing.
21	A. It basically it's looking at a big review
22	of multiple articles, multiple studies that have been
23	published in the literature. And they're looking in
24	large numbers of patients at the risk of second primary
25	cancers in people who have had either basal cell or

1 squamous cell carcinoma in the past. 2 And what they're showing is a very significant 3 increased risk of a secondary primary -- another primary cancer, just a completely independent, additional cancer 4 in these patients who have had nonmelanomatous skin 5 cancer. 6 In this review, did these authors look at 21 7 **Q**. individual studies? 8 9 Α. Yes, they did. 10 Q. Now, if you turn to page 6, Table 3. Were these authors -- is this where you got 11 12 the data that you showed on the prior slide with respect to nonmelanoma skin cancers? 13 Yes, it is. 14 Α. If we go across here, does it show 15 ο. 16 non-Hodgkin's lymphoma and increased relative risks for 17 basal cell carcinoma and squamous cell carcinoma? Yes, it does, statistically significant, 18 Α. 19 scientifically valid increases in non-Hodgkin's lymphoma 20 among patients with squamous cell or basal cell cancer 21 of the skin. Now, you told us that researchers have looked 22 Q. into what might be increasing the risk in both types of 23 24 cancers. I'll ask you to turn to page 8, and we'll see 25 5151

if this is what you're referring to. 1 Α. Yes. 2 3 **Q**. Are you there, Doctor? I am. 4 Α. So you see the sentence that says "There are 5 Q. several plausible biological mechanisms -- " 6 Yes, I do. 7 Α. -- "that could explain the association between 8 ο. 9 nonmelanoma skin cancer and risk of other cancers, including immunosuppression." 10 11 Does that relate to the immune system? Yes, it does, weakening of the immune system. 12 Α. "Chronic inflammation." Do you see that as a 13 0. risk in both skin cancers and non-Hodgkin's lymphoma? 14 15 Yes, cells that are seen -- yes, turning over A. of these lymphocytes and the possibility of an error. 16 17 Is ulcerative colitis an autoimmune condition Q. that might relate in chronic inflammation? 18 Yes, it does. 19 A. You see "variation in DNA repair efficiency." 20 0. 21 Is that related to that process you were telling us about, how we can have genetic damage but our 22 23 bodies repair it naturally? Yes, that is what I meant. And in the Cho 24 A. article that we looked at a moment ago, he looked at DNA 25 5152

repair mechanisms in these patients with basal cell 1 2 carcinomas and was able to show that 20 percent of them 3 did have errors in DNA repair. And that could be consistent with other cancers as well. 4 **Q**. I want to look above. 5 Did they comment on the impact of controlling 6 for potential confounders in this study? 7 Α. Yes. 8 9 And do they write "The association between Q. 10 nonmelanoma skin cancer and other cancers not only persisted but actually increased in strength among 11 studies adjusting for potential confounders such as 12 smoking status"? 13 That's what they say. 14 Α. Yes. 15 If the association increases when you control ο. 16 for confounders, what does that mean to you as a 17 researcher? It makes it more possible that this is for 18 Α. real, that this is scientifically valid. So you get rid 19 of the confounders, and it's even stronger that there's 20 21 a relationship, an increased risk between these basal cell and squamous cell cancers and development of 22 23 lymphoma. Now, we've talked about the 22 skin cancers 24 Q. and what that tells you about Mr. Pilliod's immune 25

system. Are there other indications in his medical 1 2 history that lead you to conclude that his immune system 3 may not be functioning properly? Yes. 4 Α. Now, you talked about meningoencephalitis. 5 Q. Correct. 6 A. The infection of the lining and of the tissue 7 **Q**. of the brain. 8 9 Α. Correct. You indicated that Mr. Pilliod first had 10 Q. meningoencephalitis back in 1978, is it? 11 Α. Correct. 12 And then did that brain infection come back, 13 **Q**. 14 in Mr. Pilliod's case, more than once? 15 Yes, it did. It came back four different A. 16 times. 17 Q. Is this a serious infection? This is an infection that could certainly lead 18 Α. 19 to death, could lead to serious long-term adverse 20 effects. This is -- any infection of the brain is a big deal. 21 Was it serious for Mr. Pilliod? 22 Q. 23 It was very serious. He was hospitalized, I Α. believe, for about six weeks. He was comatose, as I 24 understand, for about a month. He was exceedingly ill 25 5154

1 with this. 2 1978, he was about 36 years old at that time? ο. 3 Α. Correct. Is developing meningitis, encephalitis at age 4 Q. 36 or 38 unusual? 5 HSV meningitis, the risk of that is basically 6 A. 7 2 to 4 per million. It's very unusual. This germ is 8 common. We all get cold sores. But our immune system takes care of it. We don't get brain infections, and we 9 certainly don't get brain infections five different 10 11 times. Now, you indicated that, at first, they didn't 12 0. know what was -- "they" being Mr. Pilliod's doctors --13 14 didn't know what was causing his brain infections. Was that later identified as the herpes 15 16 simplex virus? 17 Α. Yes, it was. Will you turn to Exhibit 6417. 18 0. 19 Α. Yes. And specifically page 612. 20 0. 21 Α. 612. 22 Q. 612. 23 I see -- here it is, yes. Α. MR. ISMAIL: Permission to publish? 24 MR. MILLER: No objection, Your Honor. 25 5155

1 BY MR. ISMAIL: 2 So if we look up here at the top in this ο. 3 medical record, this relates to Mr. Pilliod. This is dated September of 2007, correct? 4 Α. Correct. 5 And discharge diagnoses, this was following a 6 Q. hospitalization? 7 A. Correct. 8 So what's the first discharge diagnosis? 9 **Q**. 10 A. HSV meningitis. What's HSV meningitis? 11 0. Herpes simplex virus. 12 A. And, here, it notes he had two episodes prior 13 Q. to this one in 2007. 14 Were there others documented in the medical 15 16 records beyond the three that are shown here? 17 Α. Yes. He had an additional episode, I believe, I need to look it up to be sure. 18 in 2001. 19 Does this discharge record show his diagnosis 0. for ulcerative colitis? 20 Yes, it does. 21 Α. Now, how did they go about identifying that 22 Q. 23 Mr. Pilliod's brain infections were coming from this 24 herpes virus? They did a spinal tap. And they removed 25 A. 5156

spinal fluid, and that feeds the brain. You can tell --1 2 you can get a lot of information about what's going on 3 in the brain by looking at the fluid that surrounds it and feeds it. 4 And that fluid was tested in a very, very 5 sensitive and specific way for HSV, something called 6 PCR, polymerase chain reaction. But in a very, very 7 sensitive and specific assay, this spinal fluid was 8 positive for HSV. And that proved what the doctors had 9 10 believed all along: this was HSV. 11 After this hospitalization, Mr. Pilliod Q. received antiviral treatment? 12 Yes, he did. 13 Α. What did he receive? 14 Q. He received something called valacyclovir. 15 Α. And that will treat HSV. So he's been on that 16 17 valacyclovir since 2007 and has not had another event. He's been treated for HCV. 18 19 While he was actively infected with the 20 meningoencephalitis, on three occasions, he was treated for HCV using specific drugs. One called acyclovir was 21 not available when the first diagnosis was made, the 22 23 first episode was made. But he's been treated for HCV 24 on these later episodes and continues to be treated for 25 HCV -- HSV. Sorry.

1 Q. You talked about the rarity of having one 2 episode of HSV -- herpes simplex virus -- induced brain infection. 3 If you turn to Exhibit 6589, I'll ask you to 4 identify that article. 5 6589. 6809, I have. 6 A. I'm sorry. 6569. I'm sorry. 7 Q. MR. MILLER: Your Honor, we need to approach 8 9 on that one. THE COURT: 10 Okay. (Sidebar discussion not reported.) 11 BY MR. ISMAIL: 12 Dr. Levine, you have that article in front of 13 Q. you? 14 Yes, I do. 15 A. 16 Is that the Bradshaw publication? Q. 17 Yes. Α. And in terms of the -- does this discuss the 18 0. 19 herpes simplex virus encephalitis in adults? 20 A. Yes, it does. And I would like you to turn to page 3 of this 21 Q. publication. 22 23 Yes. Α. 24 And in that carryover in the top left Q. paragraph, do these authors talk about the prevalence of 25 5158

1 having this brain infection due to the simple herpes 2 virus? 3 Α. Yes, it does. 4 ο. What do they say? They say that the incidence, the development 5 Α. over time, of HSV encephalitis is estimated to be 6 between two and four cases per million, both globally 7 and in the United States. 8 9 And so when you consider how rare of a ο. condition a brain infection is from the herpes virus, is 10 it significant to you that Mr. Pilliod had that on five 11 separate occasions? 12 It would be significant to me if he had it on 13 Α. If he had it on five occasions, it means 14 one occasion. 15 to me something is wrong with his immune system. Now, has Mr. Pilliod experienced lasting 16 0. 17 consequences from the episodes of these brain infections that he has in his medical history? 18 Yes, he has. 19 Α. 20 Q. And what has he developed as a result? He has developed, according to the records, 21 Α. seizure disorders, complicated seizure disorders. 22 23 Recently some information related to his higher cerebral function -- his memory, his ability to use words 24 25 properly.

5159

Q. If you turn to Exhibit 6396 in your binder. 1 2 Yes. Α. 3 I'm going to ask if you can identify that 0. medical record for us. 4 Yes. It is a record from Dr. Stan Lin, 5 Α. Mr. Pilliod's neurologist, one of them, and it's 6 7 discussing a neuropsychiatric -- neuropsychologic evaluation, the function of Mr. Pilliod's brain 8 9 function. And this is dated February 15 of 2011. MR. ISMAIL: Permission to publish. 10 MR. MILLER: No objection, Your Honor. 11 12 **THE COURT:** Granted. BY MR. ISMAIL: 13 So we're looking up here at the top part of 14 Q. The date of this report is in February of 2011? 15 this. Correct. 16 Α. 17 Is that before Mr. Pilliod developed Q. non-Hodgkin's lymphoma? 18 19 Α. Yes. He was diagnosed in June of 2012. 20 Q. 2011. 21 I'm sorry. 2011. I'm so sorry. Α. Yes. So is this before he had chemotherapy? 22 Q. 23 Yes, it was. Α. And do they note the reason for this referral? 24 Q. It says "To evaluate the cognitive emotional 25 Α. 5160

status due to changes in cognition" -- that's higher 1 brain function -- "with history of grand mal seizure, 2 3 status post viral meningitis." And was this all before the cancer diagnosis? 4 ο. Yes, it was. 5 Α. And down below, I want to show the jury 6 Q. whether this is the incident that you were talking about 7 with the jury earlier where it says "Briefly, 8 Mr. Pilliod stated that he suffered his first grand mal 9 seizure in 1978 and was apparently in a coma for four 10 weeks, some of which was at Stanford and others at 11 12 Washington Hospital." Correct. 13 Α. Was that that first episode of 14 Q. 15 meningoencephalitis that you talked to the jury about? Yes, it was. 16 Α. 17 Does this report describe that -- whether the Q. seizure episodes and these brain infections has resulted 18 in any complications for Mr. Pilliod? 19 It indicates he did have complications --20 Α. seizure disorder, number one, and abnormalities in his 21 cognition, number two. 22 23 And if you turn to -- all right. Q. 24 If you turn to the third page of this exhibit, 25 page 241 --5161

Α. Yes. 1 2 -- down at the bottom. ο. 3 In January of 2011, does it say "The client reported that he was having sleep problem, concentration 4 difficulties, word-finding difficulties with regards to 5 nouns and numbers, and difficulty logging into an 6 account as he was unable to spell his name"? 7 Yes. It states all of that. 8 Α. 9 Is that before or after his cancer diagnosis? 0. That is before the cancer diagnosis in June of 10 Α. '11. 11 12 0. Did you see other medical records that we 13 don't have to go through here that are consistent with what is reported here by Dr. Lin with respect to how 14 significant these brain infections were for Mr. Pilliod? 15 Yes, I did go through other records in 16 Α. 17 addition. Now, we've talked about the 22 skin cancers. 18 Q. We've talked about the five brain infections from the 19 20 herpesvirus. Are there other indications from Mr. Pilliod's 21 medical records that you found significant with respect 22 23 to the immune system? 24 A. Yes. THE COURT: Counsel, can we keep it to a 25 5162
1 minimum. 2 I'm sorry. MR. WISNER: Thank you, Your Honor. 3 MR. ISMAIL: BY MR. ISMAIL: 4 What else did you find significant on this 5 Q. question of how well functioning is Mr. Pilliod's immune 6 system? 7 The other finding was the diagnosis biopsy 8 Α. proven of ulcerative colitis, which is an autoimmune 9 disease, which says to me that his immune system is 10 There may be a question of deficiency or 11 abnormal. abnormality, and this is an abnormality in the sense of 12 his immune system seeing his own body cells as foreign 13 to him and trying to kill them. 14 15 Q. If you turn to Exhibit 6376. Α. 16 Yes. 17 Can you tell us what that is? Q. This is a biopsy of Mr. Pilliod's colon. 18 Α. The date, I believe, is 9/22/2006. 19 And what was the diagnosis given by the 20 0. pathologist, if you turn to page 13, on this biopsy done 21 on Mr. Pilliod? 22 Number 4, that fourth biopsy, says 23 Α. "Inflammatory bowel disease." That's what this whole 24 topic -- kind of illness is. "IBD, inflammatory bowel 25 5163

disease, consistent with ulcerative colitis." 1 And if you look just above that, when they 2 0. 3 talk about the findings here, do they talk about whether there's any inflammation found in the left colon? 4 It says "There was marked chronic 5 Α. Yes. inflammation composed predominantly of plasma cells" and 6 so forth. 7 And does having inflammation, does that relate 8 ο. 9 in any way to that chronic antigen stimulation you were talking about with the jury earlier in your testimony? 10 Those were all the immune cells going 11 A. Yes. into that area trying to do their thing, dividing, 12 dividing, trying to get there, and the opportunity for 13 an accident as those cells and their DNA divide, an 14 15 error that could be a very specific driver mutation. Now, did Mr. -- has Mr. Pilliod been dealing 16 ο. 17 with other viruses other than the herpesvirus in his adult life? 18 19 Α. Yes. 20 Q. What is that? 21 He also had human papilloma virus, causing Α. genital warts. 22 And has he had that on more than one occasion? 23 ο. Yes, he has. 24 Α. And the jury -- we've talked about some of 25 Q. 5164

1 these articles with other witnesses, so in the interest 2 of time, are these the dates upon which Mr. Pilliod was 3 diagnosed with genital warts as a result of the HPV virus? 4 Correct, beginning in 2003 when he would have 5 Α. 6 been in his early 60s. Is it unusual of a gentleman of his age to 7 Ο. present with this virus when he did? 8 9 Yes, it is. It should have been cleared by Α. 10 his immune system many, many decades before. That would be the usual outcome. 11 12 ο. Has there been research published that looks 13 to see whether patients who have these genital warts from HPV are at an increased risk of non-Hodgkin's 14 15 lymphoma? Yes, there are studies that show a statistical 16 Α. 17 increase in lymphoma. Are these two of the studies that you 18 0. identified as part of your review of this case? 19 20 Α. Yes. And both of them show that presence of 21 HPV infection statistically increases the risk of subsequent development of non-Hodgkin's lymphoma. 22 23 Do these authors comment about what might be Q. the shared increased risk between non-Hodgkin's lymphoma 24 and the outbreak of the genital warts? 25 5165

Yes, they do. 1 A. 2 Are you showing that here on the next slide? ο. Both of them basically talk about the 3 Yes. A. commonality as an indicator of immune impairment. 4 It says Dr. Nordenvall and Dr. Blomberg is saying the 5 6 author suggests underlying immunodeficiency as an explanation. 7 Dr. Levine, have you helped us put together a 8 ο. 9 timeline to put in context all the different things you've talked about thus far with Mr. Pilliod? 10 11 A. Yes. 12 ο. Is that what we're showing here? 13 A. That's what we're showing. It's impressive. So let's unpack this. What are you showing in 14 Q. blue? 15 In blue are all of the times that he developed 16 Α. 17 either basal cell or squamous cell skin cancer. 18 0. And you have this lighter blue color here. Why is that a lighter color? 19 20 A. I made that different simply because it's 21 so -- it goes in either direction. It's so heavily an immune responsive tumor, and it's a far more aggressive 22 23 tumor than the other skin cancers that he had. So T 24 don't think of it exactly in the same way. And we know Mr. Pilliod's diagnosis was 25 ο. 5166 1 somewhere in here.

2 Correct. Α. 3 0. Did many of these skin cancers occur before he was ever diagnosed with non-Hodgkin's lymphoma? 4 Most of them did occur prior to the time 5 Α. Yes. 6 that he was diagnosed with lymphoma. So what do you have in the green? 7 Q. The green are the examples of brain infection 8 A. 9 due to the herpes simplex cold sore virus. Was 2007 when he got put on that antiviral 10 Q. treatment to try to prevent further brain infections? 11 Yes. He was treated with the antiretroviral 12 A. 13 while he had the active infections prior to that, but 14 the first time that he was ever treated continuously 15 with antivirals to prevent recurrent meningoencephalitis 16 was on that occasion in 2007. 17 And then in the gray, what do you have Q. depicted here in the gray? 18 The gray are his outbreaks of human papilloma 19 Α. 20 virus, genital warts. And then in the yellow? 21 0. The yellow is the autoimmune disease 22 Α. ulcerative colitis. 23 How was he treated for his ulcerative colitis? 24 **Q**. He was treated with hydrocortisone enemas and 25 Α. 5167

1 later received something called asacol. 2 What is hydrocortisone? 0. 3 A. Hydrocortisone is a type of -- I'll use the same word; forgive me -- corticosteroid. It's a 4 steroid. And it has tremendously powerful effects to 5 6 weaken the immune system. They were trying to weaken his immune system because his immune system was trying 7 to destroy his colon, and that needed to be stopped. 8 So 9 they used hydrocortisone enemas to try to weaken the 10 immune system and the inflammation in his colon. It turns out that cortisone kills lymphocytes. 11 It kills them. It kills B-cells. 12 Period. It kills 13 T-cells. He got hydrocortisone enemas. Were you able to determine from the records 14 Q. 15 that were available for how long he was treated with 16 hydrocortisone and at what doses? 17 No, I can't say. I never got those records, A. although I sure would have liked to have seen them. 18 Is ulcerative colitis curable? 19 ο. 20 A. No. It waxes and wanes over time, gets worse, 21 gets better, gets worse, gets better on its own. Doctor, when you look at Mr. Pilliod's history 22 Q. 23 in total -- the skin cancers, the infections of different types, the autoimmune condition -- what is it 24 telling you, as a cancer researcher and specialist? 25

What it tells me is that his immune system is 1 Α. 2 absolutely not normal. There are components, I assume, 3 that are normal. I don't know which specific component. And I don't even have a name for this. But it's all 4 I've been in that situation before related to 5 right. 6 HIV. Didn't have a name, but that was not a normal immune system. I've seen that kind of thing before. 7 I don't know what his abnormality is. Don't 8 9 think that it's everything. I know it isn't every 10 component of his immune system. But to see this kind of a history over and over -- repeated serious infections; 11 12 organisms that he should have been able to clear; 13 repeated skin cancers, 22 of them; ulcerative colitis, an autoimmune disease -- this is not a normal immune 14 15 system. And I say that based on 50 years of being a 16 doctor who deals with this stuff. This is not a normal 17 immune system. Did Mr. Pilliod's abnormal immune system, as 18 Q.

10 Q. Did MI. Filliod's abhormal immune system, as 19 you've described it, in your view, increase his risk of 20 developing non-Hodgkin's lymphoma?

A. I think that his abnormal immune system
substantially increased his risk of lymphoma. That is
the most prominent risk factored for non-Hodgkin's
lymphoma, abnormal immune system.

25

Q. At what age was Mr. Pilliod diagnosed with

1 non-Hodgkin's lymphoma? It was in 6/20/11. He was 68, I believe. 2 Α. 3 0. And are patients of that age at increased risk of developing non-Hodgkin's lymphoma? 4 Increasing age is definitely a risk 5 Α. Yes. factor for all cancer, actually, most cancer. 6 And was he of that age that put him at an 7 ο. increased risk? 8 9 Α. Yes. 10 Q. Does that mean that getting older, having another birthday, causes a patient to develop NHL? 11 12 A. No, not in any sense. There's an association 13 of risk, but it has nothing to do with cause. Now, Doctor, prior witnesses here have talked 14 ο. 15 with the jury about something they called a differential 16 for non-Hodgkin's lymphoma. 17 And these -- I don't remember who was who, but one of these is Dr. Nabhan, and one of these is 18 Dr. Weisenburger. Using the same board. 19 20 First of all, differential for non-Hodgkin's 21 lymphoma. As someone who's been a practicing doctor in this area for 50 years, does that make sense to you? 22 I normally will undergo a differential 23 Α. diagnosis. A patient comes in, and I need to look at 24 all the things that could cause those symptoms and come 25 5170

up with what the real diagnosis might be. 1 2 But a differential cause, a differential 3 ideology? No, this is not at all something that would -- that I've really seen before. 4 So when you're taking care of your patients, 5 Q. do you go through an exercise of listing risk factors 6 and crossing them out and circling others? 7 That doesn't help me. There's no point 8 A. No. 9 to that, really. That doesn't tell me anything. 10 Q. When you're teaching medical students, do you go through an exercise like Dr. Nabhan and 11 12 Dr. Weisenburger do? 13 Well, if this is supposed to be a list of the Α. possible etiologies, the causes, it isn't, because age, 14 sex, race -- I'll go through all of them, but those are 15 16 risk factors, but they aren't causes. 17 So if you're looking for causes, you really 18 have to have causes. And I quess I'm impressed by the 19 fact that many of these are not causes. Some are; some 20 are not. The other difficulty is that, in a general 21 sense, about 90 percent of diffuse large B-cell lymphoma 22 is idiopathic. We don't know what the cause is. 23 24 Eventually, hopefully, we'll know, but we don't know 25 right now.

And so, if you're dealing with a disease where 1 2 90 percent, we honestly don't know, it's very difficult 3 to put a list that has a couple of things on it when 90 percent we don't know. 4 So, no, this is not valid methodology to me 5 6 for many different reasons. What makes up that 10 percent of conditions of 7 0. NHLs for which we do know the cause of? 8 9 The most prominent of all would basically be Α. So there are a whole series of viruses 10 the infections. 11 that can cause a non-Hodgkin's lymphoma: HIV. Hepatitis C, Hepatitis B, adult T lymphoma leukemia, 12 13 Epstein-Barr virus. There are a whole series of viruses that can cause lymphoma, that are known to be causes of 14 15 lymphoma, that cause these very specific driver 16 mutations. 17 There are other bacterial infections, believe it or not, that cause lymphoma. One of them is a germ 18 19 called H. pylori. H. pylori causes stomach ulcers. No 20 big deal. It also causes non-Hodgkin's lymphoma. 21 There are many parasites that cause lymphoma. And so if one looks at poorly resourced areas of the 22 23 world, poor areas of the world, about 20 percent of all 24 these lymphomas are due to these germs. In resource-rich areas of the world, about 10 percent of 25 5172

1 all lymphomas are due to those germs. 2 If you don't have one of those known causes, 0. 3 these viruses you talked about or bacteria, how do you properly characterize that patient's non-Hodgkin's 4 lymphoma? 5 6 Α. It's difficult to do so, especially when 90 percent we really don't know. 7 Is that what the term you used earlier, 8 Q. 9 idiopathic? 10 Α. Yes. Idiopathic is there but we don't know 11 why. Does the term "idiopathic" meaning nothing is 12 0. 13 causing that patient to develop non-Hodgkin's lymphoma? They had to have all the requisites, 14 Α. Oh, no. the driver mutation, so forth. We just don't know what 15 16 did it in that given person. 17 Now, if you're going to go through this Q. exercise of listing risk factors in Mr. Pilliod's case, 18 19 is there any way to cross out age or sex or race as 20 factors that he had? They're well, well, well described. 21 No. Α. Increasing age is a risk factor for lymphoma. Male 22 23 gender is a risk factor for lymphoma. Caucasian race is a risk factor for lymphoma. You can't cross them off as 24 25 factors; they are real.

Q. Based on what you described, did Mr. Pilliod 1 2 have any of the known causes of NHL in terms of the 3 infectious processes or bacterias that you talked about with the jury? 4 Α. No. 5 6 So how would you describe or characterize his Q. non-Hodgkin's lymphoma from a cause perspective? 7 From a cause perspective, it's really 8 A. idiopathic. I can't say what caused his driver 9 I don't know what caused his driver mutation. 10 mutation. Did he, nevertheless, have risk factors for 11 **Q**. developing that condition? 12 He has a massive risk factor for developing 13 Α. lymphoma, and that was his immunodeficiency and abnormal 14 15 immune system. Drs. Weisenburger and Nabhan had pesticide use 16 ο. 17 on here, and I want to talk to you about that. 18 A. Okay. Are there certain pesticides that have been 19 Q. 20 associated with non-Hodgkin's lymphoma? 21 Α. Yes. In fact, does your hospital's website describe 22 Q. a link between pesticides, as a generic term, and NHL? 23 Yes, it does. 24 A. Now, are there multiple types of pesticide? 25 Q. 5174

Many, many. Hundreds. Maybe even more than 1 A. 2 that. 3 Does City of Hope list Roundup or glyphosate Q. as a cause or risk factor for NHL? 4 No, it does not. 5 Α. Do you believe, based on your review, that 6 Q. Roundup is a risk factor for non-Hodqkin's lymphoma? 7 I think the summary, the basis of all of the 8 A. data together says to me that, no, Roundup is not 9 associated with development of diffuse large B-cell 10 lymphoma or non-Hodgkin's lymphoma itself. 11 12 ο. Now, after Mr. Pilliod was diagnosed, did you review those records to determine how his care 13 management proceeded? 14 15 Yes, I did. A. And the jury has heard this previously. 16 Q. So if 17 you can just give us a quick summary reminder of how his care progressed after his diagnosis in June of 2011. 18 He was treated with a regimen called R-CHOP. 19 A. 20 R was the rituximab we talked about, and then the CHOP 21 chemotherapy. He had six cycles of R-CHOP chemotherapy. After about four cycles, he had a repeat scan, which 22 showed the lymphoma was clearly going away, this PET 23 scan. And after six cycles, he was said to be in 24 In other words, they repeated the 25 complete remission. 5175

1 tests that were positive before for the lymphoma, and 2 now all of those tests are negative. 3 He's had other scans since that time. Ι believe the last one that I saw was August of 2018. 4 And he remains in complete remission, which is really good. 5 6 So it's been over seven years in complete remission, highly unlikely that he would ever relapse. 7 Now, was there anything about the presentation 8 ο. 9 of Mr. Pilliod's DLBCL that you thought was unusual, just in terms of his symptoms, his scans, his imaging 10 that looked unusual to you? 11 I've seen unusual cases, as I've 12 Α. No. 13 discussed, in the past. This was kind of a regular diffuse large B-cell lymphoma, if you will. 14 Is there anything in his medical records or 15 ο. test results that suggested to you that there must be 16 17 some chemical exposure that caused his DLBCL? 18 Α. No. Did you see anything in his workup, his 19 ο. 20 history, his presentation that would lead you to rule in 21 Roundup as a reason why he developed this cancer? 22 Α. No. Now, did you consider the fact that 23 ο. Mr. Pilliod was exposed to Roundup? 24 Of course. 25 Α. 5176

Q. That was part of the materials that were 1 2 provided to you? 3 A. Absolutely. And based on everything that you've described, 4 ο. do you believe Roundup played any role in the 5 development of Mr. Pilliod's NHL? 6 Based upon the entirety of the data, I feel 7 Α. that Roundup did not have anything to do with his 8 development of non-Hodgkin's lymphoma. 9 Are you aware that Mr. -- that Mrs. Pilliod 10 Q. developed central nervous system lymphoma in 2013? 11 I am. Α. 12 And you reviewed portions of her deposition 13 Q. testimony? 14 I did. 15 Α. 16 Did you consider that fact when assessing ο. Mr. Pilliod's case? Were you aware of that fact as you 17 were assessing Mr. Pilliod's case? 18 19 Yes, I was aware of that fact. A. Now, in terms of -- first of all, is central 20 Q. 21 nervous system lymphoma the same thing as systemic DLBCL? 22 23 They both are, quote, diffuse large No. Α. B-cell lymphoma, but primary central nervous system 24 diffuse large B-cell lymphoma is an entirely different 25 5177

entity. It has a different classification system. 1 It 2 is a separate entity. It's not the same as diffuse It is -- the cause is different. 3 large B-cell. The treatment is different. The prognosis is different. 4 So there's no relationship between primary 5 central nervous system lymphoma and diffuse large B-cell 6 They are completely different diseases. 7 lymphoma. Now, in terms of the question of whether two 8 ο. people living in the same house or a husband and wife 9 can develop the same cancer, based on the prevalence of 10 non-Hodgkin's lymphoma, would you expect to see that 11 occur from time to time? 12 13 Α. Sure. You'll see it by chance. And has that been described in the medical 14 ο. 15 literature as well? Yes, it has. 16 Α. 17 Have researchers looked to see whether that Q. 18 development of non-Hodqkin's lymphoma in a household 19 occurs any more frequently than you would expect just 20 based on the background rate of NHL? There are several studies which have 21 Yes. Α. looked at that issue --22 And have you looked at that yourself? 23 ο. Yes, I have. 24 Α. The jury has seen these papers before, so 25 Q. 5178

1 we're not going to go through them in any great detail. 2 But, in terms of the research, there are 3 couples who are reported here, both of whom have -- both husband and wife have non-Hodgkin's lymphoma. 4 Α. Correct. 5 I think, in one of these papers, it was nearly 6 Q. 100 couples, both husband and wife had the disease; and 7 another, it was 50 or 60, to that effect? 8 9 Α. Yes. And so when these researchers looked to see is 10 Q. 11 that happening more common in couples than you would 12 expect to see in the background rate, what did they find? 13 They found that it was the same as the 14 Α. 15 background rate. There were other cancers, for example, tobacco-related that were related, both couples -- both 16 17 people smoking, but not lymphoma. There was no increase in lymphoma beyond what would be expected in the normal 18 population. 19 20 **Q**. So, based on this research, does this -- how 21 do you assess this case here? Is it -- because Mr. Pilliod had one form of NHL and Mrs. Pilliod had a 22 23 different form of NHL, does that mean it has to be some environmental cause that led them to develop their 24 individual cancers? 25

Just as in these large studies, there's 1 A. No. no evidence that there is any kind of commonality, if 2 3 one member of a couple gets lymphoma, that the other The data doesn't show that. 4 will. Now, one of the prior witnesses for the 5 Q. plaintiffs who testified here went through this exercise 6 on a flip chart. And I'll just describe it to you and 7 ask for your opinion. 8 9 It was described that the risk of getting 10 DLBCL is 1 in 120 on a population basis. And then they multiplied 1 over 120 times 1 over 120, I quess to say 11 12 two people getting the condition. 13 As I'm describing that opinion -- methodology 14 to you, does that make sense to you as a cancer 15 researcher? No, it really -- I don't understand it, but it 16 Α. 17 doesn't make sense to me. You have to look at these cases no matter what. Mr. Pilliod had a real increased 18 19 risk for developing lymphoma due to his immune system. 20 And to take two numbers and multiply them 21 together to give you a risk factor for a given couple, that doesn't make sense to me. 22 So let's talk about that further. 23 Q. So Mr. Pilliod has ulcerative colitis? 24 25 Correct. Α. 5180

Q. And what's the prevalence of that? 1 2 Oh, I don't know. I'd have to look it up. A. 3 The prior witnesses said it was about 1 in Q. 400. 4 Okay. 5 A. MR. MILLER: Object to leading. 6 Sustained. THE COURT: 7 MR. ISMAIL: Fine. 8 9 BY MR. ISMAIL: 10 Q. Mr. Pilliod's encephalitis, you said was --2 to 4 per million. 11 A. And so you talked about the fact that he had 12 Q. multiple skin cancers, correct? 13 14 Correct. Α. Approximately what's the -- let's pick one of 15 Q. 16 them. Melanoma, for example -- the risk of getting a 17 melanoma? I'd have to look that one up too. 18 Α. Would it make any sense, Doctor, to say, well, 19 Q. 20 Mr. Pilliod's risk of getting a brain infection from herpes is 2 in a million, and I'm going to multiple it 21 by his risk of getting ulcerative colitis to see what 22 23 are the odds that the same person would have both conditions? 24 That's just not scientifically valid in 25 Α. No. 5181

1 any sense. It doesn't mean anything. 2 What drives his risk of getting skin cancer or ο. 3 encephalitis? What's driving his risk is his abnormal immune 4 Α. system. 5 Doctor, I will not --6 Q. MR. ISMAIL: Your Honor, I was going to switch 7 subjects. Did you have a 12:00 stop today or --8 THE COURT: Okay. Since it's noon, and you're 9 10 going to switch, let's do our lunch break now. Ladies and gentlemen, we're going to have a 11 45-minute lunch today and resume at a quarter of the 12 13 hour. Don't talk about anything you heard in the courtroom this morning. Now, did you, as part of your review, also look at the published literature regarding whether or 4 not there's a relationship between glyphosate-based 5 6 products and non-Hodgkin's lymphoma? Yes, I did. 7 Α. And did you also review, as part of that, the 8 ο. 9 regulatory review that summarized and assessed that same data? 10 Yes, I did. 11 A. Now, the jury has heard a lot about that 12 0. information. So one of the disadvantages of going last 13 is we're not going to repeat everything the jury has 14 But I do want to get your opinion based on your 15 heard. review. Okay? 16 17 Α. Sure. Now, when you looked at the various summaries 18 **Q**. of the scientific data, did you also review the 19 summaries of the animal carcinogenicity studies and the 20 mechanism studies? 21 Yes, I did. 22 Α. 23 And did you factor those reviews into your Q. opinions that you arrived at? 24 I certainly did. 25 Α. 5183

1	Q. And did you read the epidemiology studies, the
2	likes of which the jury is well familiar?
3	A. Yes, I did.
4	Q. Did you undertake that epidemiological review
5	with the same process that you would as a peer reviewer
6	or as a researcher looking at medical literature?
7	A. Yes. I looked at it very carefully.
8	Q. And when you looked at the totality of that
9	information, what opinions did you arrive at with
10	respect to whether or not there's a relationship between
11	products like Roundup and non-Hodgkin's lymphoma?
12	A. When I looked at all of the data, reviewed it
13	really carefully, the bulk of the data, to me, indicates
14	that glyphosate is not a cause for non-Hodgkin's
15	lymphoma, nor is it a risk factor.
16	Q. One of the things you talked about this
17	morning is something called the SEER database.
18	A. Yes.
19	Q. Can you remind us what the SEER database is?
20	A. The SEER database is the United States' way of
21	looking at cancer across the entire population to figure
22	out if there are problems that we need to address,
23	certain things going up that we did not expect or going
24	down that we did not expect.
25	So I used that. And I've used it a great deal
	5184

in my entire career as I look at lymphoma and try to figure out new things that we didn't really understand in the past.

Q. So well before we came to you and asked for
your opinions in this case, did you have experience
looking at the SEER data in terms of these -- the rate
of non-Hodgkin's lymphoma?

8 A. Yes, I had a lot of experience. I've worked
9 with it a great deal, and I've used it many times in the
10 research that I've done.

11 Q. Now, have you looked to see the trends -- the 12 national trends in NHL in the United States over the 13 last couple of decades?

A. Yes, I have.

15 Q. And did you look at that same time period to 16 see what the usage of glyphosate-based products were 17 over that same period of time?

A. I did.

19 Q. And have you helped us put together a graph to20 show that relationship based on your review?

A. Yes, I did.

Q. So let's just orient everyone here to whatwe're looking at.

What is the orange line here?

A. The orange line is the incidence, the

development over time, of new diagnoses of non-Hodgkin's 1 2 lymphoma. It's given cases per 100,000 people. That's 3 how the US, that's how the NIH, that's how SEER, that's how EPA, that's how others look at data of that sort, 4 by -- per 100,000 people. That's what that shows. 5 Q. Okay. So I think you told us in that last 6 answer, but what is the source of the data for the rate 7 of NHL? 8 The source of the data are these mandated SEER 9 Α. 10 registries, tumor registries, population-based, as well as other agencies. The National Cancer Institute, for 11 12 example, will use those kinds of figures. Now, if we look back to 1974 and look at this 13 **Q**. 40-year trend line, I want to focus first on this 14 initial sort of kink here in the data. 15 16 Α. Yes. 17 Were you actually a practicing oncologist in Q. cancer research during this time period? 18 Yes, I was. 19 A. 20 Q. And did you look at this data back then for 21 any particular purpose? I looked at it very carefully because I 22 Α. Yes. 23 was seeing these unusual lymphomas in these young men. And my question was whether that was just me at the LA 24 County Hospital or was that really a trend in the United 25 5186 1 States.

2	So I went to this registry. And you can see
3	there's an uptick there. And it went up between
4	actually, it started early 1980s, up until 1990,
5	significant increase year over year of these lymphomas.
6	From 1990 until about 2000, when it started to
7	be flat. Little bit of an increase, but not like it was
8	before.
9	And that, in my own view, was related and
10	then, after that, 2000 and beyond, it's pretty flat. If
11	anything, there's a little suggestion it might be going
12	down a little bit, as you can see. But it certainly is
13	not going up the way it did in the early 1980s and '90s.
14	Q. And what accounted for this increase in NHL
15	that you observed in the late '80s into the early '90s?
16	A. What accounted for the increase turned out to
17	be the AIDS-related lymphomas.
18	Q. And is it generally accepted, Doctor, that,
19	over the last couple of decades, the national incidence
20	of NHL has plateaued?
21	A. Yes. And what's really happened is, around
22	1996, we developed multiagent therapy, different drugs
23	to treat HIV. They're very, very successful. And we
24	cannot cure HIV, but we can control it so that people
25	live normal life spans, almost normal life spans. And
	5187

the risk of these lymphomas substantially went down. 1 And so that's the flat part. 2 3 0. And what is the blue line? The blue line is the use of glyphosate in the 4 A. United States in pounds over years, over time. 5 Q. And where did you get that data? 6 I got it from the Environmental Protection 7 Α. The EPA had very specific data about glyphosate 8 Agency. 9 usage in the U.S. And so I think the jury has heard from other 10 Q. witnesses that, beginning in the mid 1990s, the usage of 11 glyphosate went up across the United States. 12 13 Is that consistent with the graph that you're showing here? 14 Definite increase, significant increase 15 Α. Yes. 16 in the use of glyphosate over time. 17 And what opinions, if any, Doctor, do you draw Q. from the juxtaposition of these two rates as you've 18 shown them here in this graph? 19 20 A. My understanding of this is that, as 21 glyphosate use increased substantially in the United States -- and, as I understand it, one of, if not the 22 most commonly used, substance of its kind in the United 23 States -- if this really were a major cause or a cause 24 of non-Hodgkin's lymphoma, I should have seen the rate 25

1 of new non-Hodgkin's lymphomas going up, just as I saw 2 the rate go up when something new called HIV came along. 3 But I don't see that. And is this one piece of the puzzle, as it 4 ο. were, that informs your opinion in this case? 5 6 Α. It's population-based data, and it's Yes. helped me many times in my career to understand what 7 might be going on with different potential causes of 8 9 lymphoma. Now, with respect to the epidemiology that you 10 Q. looked at in this case, have you looked at studies 11 that -- some of which control for other pesticide 12 13 exposures and some of which that do not? 14 Α. T have. 15 Doctor, which do you believe to be the more ο. reliable data to look at if a study reports adjusted and 16 17 unadjusted data? That's a really important issue. 18 Α. If you don't -- if there are many pesticides, herbicides, other 19 20 kinds of factors that a person has been exposed to, and 21 you're looking at the results for one specific pesticide or herbicide, you have to factor in everything else that 22 the patient has been exposed to. 23 And if you don't factor it in, it's not a 24 valid assessment of what's really happening. 25 You have 5189

1	to look at each independently. You can't look at a
2	whole glop and say that this one thing caused what
3	was actually, the exposure was much, much bigger than
4	that one thing.
5	Q. And so would you look at adjusted or
6	unadjusted data?
7	A. I would always look at adjusted data, adjusted
8	for those other factors that may be involved.
9	Q. Now, are these all studies that you reviewed
10	as part of your work in this case?
11	A. Yes.
12	Q. And the jury is familiar with all of them, so
13	we won't go through again and show the data.
14	But if you look through here, it says
15	"relative risk adjusted for other pesticides, if
16	available." Is that correct?
17	A. Correct.
18	Q. Is it the case that not every study reports
19	adjusted data?
20	A. That's true.
21	Q. But where there was adjusted data, which
22	did you look to that for the relative risks?
23	A. That would be most important to me. That
24	would be most reliable and valid scientifically,
25	certainly.

And when you looked at -- across this 1 Q. collection of studies, looking at the adjusted data, did 2 3 any of them report a statistically significant increased risk? 4 Every one of these studies, the -- none 5 Α. No. of these are statistically significant, none of them. 6 And the McDuffie and De Roos 2003 studies that 7 Ο. the jury has heard a great deal about, where do you 8 9 report that data on this graph? 10 A. Well, that was reported -- they are included within the North American Pooled Project. So that was 11 an ability to take McDuffie and De Roos, add some other 12 13 cases, and make it a larger study. So that's where they 14 are. Do some of these studies report on diffuse 15 ο. large B-cell lymphoma in particular, the likes of which 16 17 Mr. Pilliod had? 18 Α. Some do, yes. 19 Q. And have you helped put together a chart to 20 look at that data as well? 21 Α. Yes, I did, because that's what Mr. Pilliod 22 had. Now, again, some of these are not adjusted; 23 Q. for example, Orsi, I believe, Eriksson, and Chang. 24 But even when you look at adjusted and some 25 5191

1 unadjusted data, did any of them show a statistically 2 significant increased risk of DLBCL? 3 Α. No, none of them, even at the higher dose level or exposure levels on Andreotti's paper. 4 And how do you assess the Leon paper down here 5 Q. at the bottom? 6 Leon includes some of Andreotti, not all of 7 Α. it. So I think it went through 2011, and Andreotti 8 several years beyond that. So it includes some of it 9 but not the full data set. 10 11 Is that properly characterized as a borderline 0. 12 finding? The confidence interval is 1.00 to 13 Α. Yeah. 1.85. So it's very gray; it's borderline. 14 15 But when you look at the totality, what does Q. 16 it tell you as a cancer researcher? 17 The totality tells me that there is no A. relationship here as far as use of glyphosate and the 18 19 subsequent development of diffuse large B-cell lymphoma. 20 It's not there. Did you also consider the regulatory reviews 21 ο. as part of your work in this case? 22 23 T did. Α. And did you find them significant in arriving 24 0. at your own opinions? 25 5192

1	A. I certainly did.
2	Q. How so?
3	A. Well, the regulatory agencies, their job is to
4	assure the public health, to do whatever they can to
5	make sure that the public is not exposed to things that
6	are toxic or difficult to the health of the people who
7	live here.
8	That's a big responsibility. They're going to
9	look at these data very, very carefully. They are
10	responsible, ultimately. And I was impressed with the
11	findings around the world.
12	Q. Did you look at the findings of the various
13	agencies in the European Union?
14	A. Yes, I did.
15	Q. Did you look at the findings of the health
16	agencies in Canada?
17	A. Yes, I did.
18	Q. And in the United States?
19	A. Yes, I did, the EPA.
20	Q. In New Zealand?
21	A. Yes, I did.
22	Q. And what did you find when you looked at those
23	reviews?
24	A. I looked at the reviews, which were very, very
25	carefully done. They analyzed all of the data. They
	5193

analyzed more data than other studies had.

1

2 And, basically, what they conclude, there is no -- glyphosate does not cause cancer in humans. 3 And that is the United States EPA. That is Japan. 4 That is New Zealand. That is Australia. That is Germany. 5 That That is the entire European Union, all of 6 is France. those countries. 7

8 The regulatory agencies in all of those 9 countries come to the conclusion that glyphosate is not 10 a hazard in terms of cancer to humans. And that, to me, 11 was very weighty data.

12 Q. Now, let's wrap up what we've talked about 13 today, and then we'll have Mr. Miller have an 14 opportunity to ask questions.

So in summary, Doctor, when you look at Mr. Pilliod's case and his presentation and the testing that he had done for his DLBCL, did you see anything there to suggest any unusual course of his disease or presentation of his disease?

A. No. It was very typical. I've seen new
things when they arise. This wasn't new; it was usual.

Q. And when you look at his medical records, did you determine whether or not his immune system, as evidenced by his various diseases and conditions he's developed over the years, was functioning normally?

I felt very strongly that his immune system 1 A. 2 could not be functioning normally to have had all of those illnesses that he's had over all of those years. 3 And that would dramatically increase his risk of 4 non-Hodgkin's lymphoma. 5 Do you believe that the evidence supports that 6 Q. Roundup at relevant human doses causes non-Hodqkin's 7 lymphoma? 8 9 Α. I believe that the totality of all the No. 10 evidence together says that there is no relationship 11 between Roundup and the increased risk of lymphoma or causing lymphoma. 12 Did Roundup contribute to Mr. Pilliod's DLBCL? 13 0. No, Roundup did not contribute to his 14 A. 15 lymphoma. 16 Thank you, Doctor. MR. ISMAIL: 17 No further questions, Your Honor. THE COURT: Cross-examination. 18 19 MR. MILLER: Thank you, Your Honor. 20 **CROSS-EXAMINATION** BY MR. MILLER: 21 Hi, Doctor. Did you have a good lunch? 22 Q. 23 Yes, I did. Α. 24 Q. Great. Great. Give me a second, if you would. 25 5195

1 We've got a lot to cover. We'll try to do it 2 as efficiently as we can. Okay? 3 Α. Sure. I'm going to grab a piece of paper and put it 4 ο. up here and sort of write some stuff down. 5 What we're really going to be talking about is 6 what caused or contributed as a cause to Mr. Pilliod's 7 8 diffuse large B-cell lymphoma, right? 9 Α. Age did not cause it, right? 20 All right. We agree his race did not cause 21 it, right? 22 23 Correct. Α. 24 Q. Okay. All right. "Did not cause." All right. 25 5196

1 All right. His gender didn't cause it? Being 2 a male didn't cause him to get non-Hodgkin's lymphoma? 3 Α. No, it didn't. You're right. All right. "Did not cause." All right. 4 ο. You and I agree obesity didn't cause his 5 non-Hodqkin's lymphoma? 6 7 That's true. Α. Right. 8 ο. 9 Okay. So, as I understand it, you went through Mr. Pilliod's extensive medical history, right? 10 11 Correct. A. And you went through it with the idea that --12 0. not that it caused his non-Hodgkin's lymphoma, but what 13 14 it does, it shows you he had a weakened immune system. Is that fair? 15 It shows he had a weakened immune system and 16 Α. 17 an abnormal immune system. Right. So what you told us was you didn't 18 **Q**. 19 know what caused his non-Hodgkin's lymphoma, right? 20 A. That's correct. 21 Q. Okay. L-E-V-I-N-E? 22 23 That's right. A. And I'm pronouncing it right, Levine? 24 Q. 25 Yes, you are. Α. 5197

1	Q. All right. "Does not know what caused Al
2	Pilliod's non-Hodgkin's lymphoma," right?
3	A. Correct.
4	Q. Where you and I will, with respect, disagree
5	with each other is you did not consider Roundup as a
6	cause, right?
7	A. No, that's not true. I definitely considered
8	Roundup. I have to keep an open mind.
9	And because I do keep an open mind, I'm able
10	to see things over the years. For example, HIV; for
11	example, Hepatitis C and others. No, I look at
12	everything. You can't close your mind as a doctor. You
13	have to look at everything, and I did.
14	Q. That's absolutely well said.
15	You considered it, looked at the evidence, and
16	then completely rejected that Roundup could cause it.
17	Is that a
18	A. I didn't reject it. The data my
19	interpretation of the data allowed me to reject it as
20	the cause of his lymphoma.
21	Q. And of anyone's lymphoma. You think there's
22	anybody in the world that has non-Hodgkin's lymphoma as
23	a result of Roundup?
24	A. The totality of the data, as I have gone over
25	it extremely closely and carefully, does not suggest

1	that glyphosate is associated with an increased risk of				
2	diffuse large B-cell lymphoma or of non-Hodgkin's				
3	lymphoma.				
4	Q. All right. Okay. That's your opinion. I				
5	know that's where we're going to have respectful				
6	disagreement.				
7	But just to sum up, though, age didn't cause				
8	it, race didn't cause it, gender didn't cause it,				
9	obesity didn't cause it; and, as far as medical history,				
10	you're not suggesting it caused it, but you're				
11	suggesting it showed a weakened immune system, right?				
12	A. Which allowed the cancer, whatever caused it,				
13	to occur at an increased risk.				
14	Q. And you and I agree that everyone who gets				
15	non-Hodgkin's lymphoma, by definition, has a weakened				
16	immune system?				
17	A. Yes. That's part of any cancer, an				
18	abnormality of mild or more. That's what age is all				
19	about, for example.				
20	Q. All right. So Al Pilliod fits squarely in				
21	75,000 people a year in America get non-Hodgkin's				
22	lymphoma, right?				
23	A. Did you say "dead of"? I don't know what				
24	you're saying.				
25	Q. I'm sorry. 75,000 people, approximately, a				
	5199				

1	year in America get told they have non-Hodgkin's
2	lymphoma; is that fair?
3	A. Yes, it is.
4	Q. And every one of them, by definition, has a
5	weakened immune system because they couldn't fight it
6	off?
7	A. That is true.
8	${f Q}$. Okay. And you and I agree that a chemical can
9	be the damage that starts the DNA problem that leads to
10	non-Hodgkin's lymphoma, right?
11	A. Sure. It depends on the chemical and so
12	forth, but certainly.
13	Q. And we agree a chemical can cause DNA damage
14	resulting in non-Hodgkin's lymphoma, right?
15	A. Yes.
16	Q. Okay. Can we agree that Roundup is a
17	chemical?
18	A. Roundup is a chemical.
19	Q. Okay. And although you didn't know it was a
20	pesticide on March 11th, you and I agree now Roundup is
21	a pesticide?
22	A. What I believe I said is that Roundup is an
23	herbicide, and herbicides are considered under the
24	larger umbrella of pesticides, so one could say it is
25	both.

1	
1	Q. But you learned that on March 11th?
2	A. No, not on March 11th. I said it on March
3	11th. I made an error when I initially said it was an
4	herbicide and not a pesticide. In fact, it's both.
5	Q. So we do now agree that it is a pesticide?
6	A. It is a pesticide.
7	${f Q}$. And we agree that the website at the City of
8	Hope lists pesticides as a cause of non-Hodgkin's
9	lymphoma?
10	A. Yes, in a general statement.
11	Q. Okay. And you agree with that?
12	A. Yes, I do.
13	Q. I bet you and I can agree, but let's find out.
14	There's a scientist at City of Hope that knows more
15	about the relationship between pesticides and
16	non-Hodgkin's lymphoma than perhaps 99.99 percent of the
17	world?
18	A. I don't know, but I think it's probably true.
19	Q. Who would that be?
20	A. That's Dr. Weisenburger, someone I respect
21	highly.
22	Q. Sure. I hope I don't misspell his name.
23	All right. Now, you put in your report, and I
24	think you'll agree right here, that ulcerative colitis
25	in and of itself is not a cause of diffuse large B-cell
	5201

1 lymphoma?

2	A. That's true.
3	Q. And although everyone that gets non-Hodgkin's
4	lymphoma has a problem in the immune system, there's got
5	to be a defect or a hit at the cellular level in order
6	to cause cancer, right?
7	A. There are many steps along the pathway to get
8	cancer. Certainly one of them involves specific types
9	of driver mutations at the DNA, if that's what you
10	meant. I wasn't sure.
11	Q. Sure. Driving mutation. You've also called
12	it a hit-and-run mutation, right?
13	A. I have in other circumstances, yeah.
14	Q. Sure. And for that first hit to DNA, before
15	the cancer appeared, it can often takes years and years,
16	right?
17	A. The first hit can happen anytime,
18	theoretically.
19	Q. Sure. If someone came into your office, and
20	you found out I know lung cancer isn't your
21	specialty, but somebody and you had to diagnose that
22	person with lung cancer, and they said, "But, Doc, I
23	haven't smoked in 20 years," you'd probably tell them,
24	"Well, look, the damage is done, and it led 20 years
25	later to the cancer." That's what scientists

1 understand, right? 2 Well, yes. Actually, it's 15 years, but yes. Α. 3 Okay. Now, although you don't agree with the Q. conclusion, you do know that there was this 4 International Agency for the Research of Cancer, right? 5 6 Α. Forgive me. Which one? International Agency for the Research of 7 **Q**. Cancer. 8 9 IARC. Yes, I do. Α. 10 Q. In fact, in the other report you did for Monsanto, you cited them about nine times as authority 11 for about nine different issues. 12 13 Do you remember that in that report? I don't remember nine, but I certainly did 14 A. 15 speak to it. 16 And you know that that agency, also called ο. 17 IARC, invited 17 experts from around the world to look at this issue of Roundup and non-Hodgkin's lymphoma, 18 right? 19 20 A. Yes. 21 Q. Let's just look for a minute. It's been a long trial, so some of us -- I have -- have forgotten 22 who the folks are. 23 24 MR. MILLER: May I approach, Your Honor? 25 THE COURT: Yes.

1 BY MR. MILLER: 2 Here, Doc. ο. 3 A. Thank you. Can we put that up on the screen? 4 MR. MILLER: It's been up on the screen before, I believe. 5 Permission to publish, your Honor. 6 **THE COURT:** I believe it has. 7 **MR. MILLER:** 3029. 8 9 BY MR. MILLER: This is the members of the working group that 10 Q. looked at the issue of whether Roundup was a probable 11 human carcinogen, right? 12 They were looking at the issue of glyphosate 13 A. in relationship to the development of lymphoma, yes. 14 Yes, ma'am. And not just glyphosate, but 15 ο. glyphosate formulations, right? 16 17 Α. Correct. And this is not -- you have a very 18 **Q**. distinguished career, and we've talked about what you've 19 20 done. But you were not invited to this meeting, right? 21 No, I was not. Α. And you wouldn't expect to be because you 22 Q. 23 don't really research pesticides and non-Hodgkin's lymphoma? 24 25 Α. That's true.

Q. Some of the people that were invited and voted 1 to conclude that, in fact, Roundup did cause 2 3 non-Hodgkin's lymphoma was a gentleman from the Environmental Protection Agency. You see that? 4 Peter Eqeqhy? 5 6 Α. Yes. And from --7 **Q**. Although it does say he was unable to attend. 8 A. 9 Oh, you're right. There were two people from 0. One attended; one did not. I'll rephrase. 10 the EPA. Aaron Blair, you understand he was on that 11 committee, right? 12 13 Α. Yes. Gloria Jahnke from the National Institute of 14 Q. Environmental Health Sciences? 15 Yes, she's listed. 16 Α. 17 Q. And Dr. Jameson. He got the chance to visit with us here in the courtroom. 18 19 Have you read his expert report or deposition? 20 A. I don't remember whether I have, actually. Ι think T did. 21 Matthew Martin from the Environmental 22 Q. 23 Protection Agency did, in fact, attend, right? Yes. 24 A. But you're also right. The other gentleman, I 25 Q. 5205 1 believe, did not attend.

2	Matthew Ross from Mississippi State. We have
3	someone from Texas A&M. And you mentioned New Zealand.
4	We have someone from New Zealand, don't we?
5	A. Yes.
6	Q. And we have someone from Canada too, don't we?
7	A. Yes.
8	Q. And we have Lauren Zeise from the California
9	Environmental Protection Agency, right?
10	A. Yes, she's listed.
11	${f Q}$. All right. And you understand that they voted
12	unanimously to conclude that Roundup was a probable
13	human carcinogen, right?
14	A. A probable human carcinogen, yes.
15	Q. And that was not an unscientific conclusion,
16	was it?
17	A. No, it wasn't at that time.
18	Q. I understand. And here's what they decided.
19	MR. MILLER: If I could approach, Your Honor.
20	BY MR. MILLER:
21	Q. Here is Exhibit 2048. I'm going to hand this
22	to you, Doctor.
23	MR. MILLER: Your Honor, did I hand you two
24	copies or one?
25	THE COURT: You did.
	5206

MR. MILLER: 1 Sorry. BY MR. MILLER: 2 3 Okay. And have you reviewed this publication Q. in the Lancet where they reported the news of their 4 finding about Roundup and non-Hodgkin's lymphoma? 5 Yes. Well, glyphosate. 6 Α. Right. Well, it's also about glyphosate and 7 0. its formulations. Are you aware of that ma'am? 8 9 Α. Yes. 10 Q. All right. Let's go, if we can, to the back page. The jury has seen this before. Indulge me, but 11 it's been a while. Let's look at the bottom right side. 12 13 Let's go to the glyphosate and glyphosate-based formulations. I'm going to highlight that for you so we 14 15 can all look at it together there. Glyphosate and glyphosate formulations induced 16 17 what kind of damage? It says DNA and chromosomal damage in --18 Α. that's what it says. 19 20 Q. In mammals and in human and in animal cells, 21 right? Yes. 22 Α. And DNA damage is what can ultimately lead to 23 Q. 24 cancer, right, if the body can't repair and fight it off? 25 5207

It's not DNA damage in general that can lead 1 A. 2 It is a very specific kind of mutation to cancer. called a driver mutation that can lead to cancer. 3 Nonspecific abnormalities, nonspecific chromosomal or 4 DNA damage, that does not necessarily lead to cancer at 5 all. 6 Sure, Doctor. And you figure these 17 experts 7 **Q**. in cancer from around the world know what DNA damage can 8 and cannot cause cancer, right? 9 I would believe so. 10 Α. MR. ISMAIL: Speculation, Your Honor. 11 THE COURT: Overruled. She can answer. 12 I believe so. 13 THE WITNESS: BY MR. MILLER: 14 Sure. And what they said was this kind of DNA 15 ο. 16 damage made Roundup a probable human carcinogen, right? 17 I disagree with their conclusions. Even on A. the bottom of what you're showing, bacterial mutagenesis 18 tests were negative. Glyphosate has not been shown to 19 20 be a mutagenesis. It does not cause mutations. They're 21 saying that right there. One study reported increases in blood markers 22 Q. 23 of chromosomal damage, right? 24 A. Yes. In residents of several communities after 25 0. 5208

1 spraying of glyphosate formulations, right? 2 Α. Right. 3 **Q**. And the working group classified glyphosate as a probable carcinogenic to humans. 4 Α. Yes, they did. I just don't agree with their 5 conclusions. 6 I understand. Now, let's continue. 7 0. Okay. The DNA defect that can cause cancer can be a 8 9 double-strand break, right? A double-strand break in itself is not a 10 Α. No. driver mutation, no. It doesn't equal the option for 11 cancer, given the other factors. 12 13 **Q**. Let me show you --**MR. MILLER:** Your Honor, may I approach. 14 I'm going to hand the witness her deposition. 15 BY MR. MILLER: 16 17 This is from March 15th when a lawyer from my Q. office came, I believe, down to Los Angeles and took 18 your deposition. 19 20 Do you remember that? Yes, I do. 21 Α. Okay. Let's look at page 143, line 4. 22 Q. Were 23 you asked this question, and did you give this answer? So that defect in the DNA could 24 "0. be a hit-and-run kind of mechanism, 25 5209

which means the agent, some agent, is 1 2 causing mutations in someone's DNA." 3 What was your answer? I said, "That's correct." 4 A. And the next question was "That defect could 5 Q. be a double-strand break, correct?" 6 I said, "It could be." 7 Α. "Could be a single-strand break?" 8 ο. I said, "It could be any number of defects, 9 Α. many different defects." 10 That's the truth, isn't it, Doctor? 11 **Q**. If the defect is a specific kind of driver 12 Α. mutation, is it causing mutation? That was what I said. 13 Which means the agent, some agent, is causing mutations 14 15 in someone's DNA. 16 Okay. You know, while everybody else was ο. 17 having lunch, I read your reports in both cases and reread your deposition. 18 19 Do you agree with me, or do you want to look? You don't use the phrase "driving mutation" in either 20 report or in this deposition. 21 Are you aware of that? 22 23 I am aware. Α. 24 Q. Okay. 25 Reasons --Α. 5210

1 Q. I didn't mean to interrupt you. 2 And one of the reasons you never used that 3 phrase was, as of March 11th, you hadn't even looked at the genotox material in this case. 4 Do you remember saying that in a sworn 5 6 proceeding? I had looked at some of that data. 7 Α. Do you remember saying in a sworn proceeding 8 ο. 9 on March 11th you had not reviewed it? On March 11th I had reviewed some of the data, 10 Α. 11 not all of the data. I had reviewed the epidemiologic 12 data carefully. You know, there's a difference between 13 0. epidemiologic data which you -- I'll take you at your 14 word, you reviewed carefully. But you did not review, 15 as of March 11, the genotox data, right? 16 17 I was not asked to do so. Α. That's right. You gave your opinion without 18 0. being asked or looking at that material. That's what 19 20 the Monsanto lawyers wanted you to do, right? 21 Α. No. I'm sorry. I'm confused. 22 Q. 23 You gave your report in this case in January, 24 right? 25 Α. Yes. 5211

Q. And as of March 11th, in a sworn proceeding, 1 2 you advised you hadn't reviewed the genotox data yet 3 because you had not been asked to review it, right? I had not been asked to comment upon it. 4 Α. And you hadn't done a Bradford Hill causality 5 Q. review of this case, right? 6 That is true. 7 Α. You hadn't been asked to do that either, had 8 ο. 9 you? As of March 11th, you had not looked at the 10 animal studies on Roundup. That's true, isn't it? 11 That is true. 12 Α. And as of March 11th, you had no opinion on 13 Q. the mechanistic data, or the genotox data. 14 That's true, isn't it, Doctor? 15 16 At that time. Α. 17 So was it this weekend that you came up with Q. the genotox opinion? 18 19 MR. ISMAIL: Objection. Argumentative. 20 THE COURT: Sustained. BY MR. MILLER: 21 When did you come up with an opinion on the 22 Q. 23 qenotox? When I got into the data and read it carefully 24 A. and saw what it really said. 25 5212

But you wrote a report telling the world that 1 Q. 2 my client's cancer wasn't caused by Roundup, and you hadn't read that stuff? 3 There is no study that shows that Roundup 4 A. causes mutagen. It is nonmutagenic. IARC says it is 5 6 nonmutagenic. EPA says it is nonmutagenic. Every one of the regulatory agencies says it does not cause 7 mutations. You need a driver mutation. 8 Another 9 patient -- never mind. Do you know who Chris Portier is? 10 Q. I don't know him. 11 A. 12 0. Have you read his deposition? Yes, I have. 13 A. Do you know who Dr. Jameson is? 14 Q. 15 A. Yes. 16 Q. Did you read his deposition? 17 Yes, I did. Α. When did Roundup come on the market? 18 0. I believe it came on the market around 1974. 19 A. 20 Q. What else is in Roundup besides glyphosate? 21 My understanding is that there are solvents, Α. there are other substances in the formulation. 22 They are 23 not exactly the same in many different varieties of this substance. 24 Do you know what people that know pesticides 25 ο.

1 call the other ingredients in Roundup? 2 I'm not sure what word they use. Α. 3 **Q**. Have you ever heard the word "surfactant" before? 4 I most certainly have. 5 A. What's your understanding of a surfactant? 6 Q. Surfactant allows a given substance to get 7 Α. into the body more carefully and the skin more carefully 8 and so forth, more completely. 9 Substance to get into the body more 10 Q. 11 completely. Is there a surfactant in Roundup? 12 I believe there is. 13 A. Can you tell us what it is? 14 Q. No, I can't. 15 Α. Can you -- have you ever heard this acronym 16 ο. 17 before, POEA? Yes, I have. 18 Α. 19 What is it? Q. I can't tell you what it stands for. 20 Α. Ι believe it is one of the surfactants that is included in 21 Roundup. 22 23 Is it included in Roundup in Europe or just Q. America? 24 I don't know. 25 Α. 5214

1 MR. ISMAIL: Objection, Your Honor. Lack of foundation. 2 3 THE COURT: Sustained. BY MR. MILLER: 4 Did you give us an opinion about regulatory 5 Q. issues in Europe? 6 Yes, I did. 7 Α. Before you would give us regulatory opinions 8 ο. about what Roundup is used in Europe and whether it's 9 safe, would you want to know what surfactant they used 10 11 in Europe? I might. 12 Α. Do you know? 13 **Q**. 14 I don't. Α. Would it surprise you to learn they don't use 15 Q. 16 POEA in Europe? 17 Α. No, it wouldn't surprise me. MR. ISMAIL: Objection, Your Honor. 18 19 THE COURT: Sustained. Stricken. BY MR. MILLER: 20 You and I agree -- and I respect and thank 21 ο. you -- you said you took Al Pilliod at his word, right? 22 23 Yes, I did. Α. 24 You and I agree that Al Pilliod started 0. spraying Roundup in 1982? 25 5215

1 Α. That's what was said. 2 Do you believe him? ο. 3 A. I have no reason to disbelieve him. Okay. And you and I agree that Al sprayed 4 Q. Roundup nine months a year for 28 years? 5 MR. ISMAIL: Objection, Your Honor. Lack of 6 There's no way for the witness to know. foundation. 7 THE COURT: Okay. If she knows or how she 8 9 knows. BY MR. MILLER: 10 Did you read Al Pilliod's deposition? 11 0. I did. 12 Α. And I'm sure you are 6 Q. as well. But my question was it was the worst stage it 7 could be at that time? 8 It was in extranodal sites. 9 It wasn't Α. Yes. 10 just in lymph nodes. It was in the organ, and the organ was the bone and the bone marrow. 11 And you agree that, not only was he diagnosed 12 Q. with diffuse large B-cell lymphoma, but his wife four 13 years later was diagnosed with a form of diffuse large 14 15 B-cell lymphoma. and say Hepatitis C caused that non-Hodgkin's lymphoma? 1 2 You can look in the lymphoma tissue and Α. No. 3 see the Hepatitis C in the lymphoma tissue, but that's done by other means other than microscope. 4 And the last matter that you wrote a 5 Q. Right. 6 report on, gave testimony on, you said Hepatitis C caused his lymphoma, and there was nothing under the 7 microscope to prove that Hepatitis C caused it, right? 8 9 Α. Do we have that? It's on page 2. Let's go to 1 2 There we are. page 2. All right. 3 -- "would permit investigation of the reasons for spousal aggregation of cancer if they were present. 4 Of the 175,000 persons who received at least one checkup 5 6 during an eight-year period, 175,000 were identified as being free of cancer" -- right? -- "except for 7 nonmelanoma skin cancer" -- right? 8 9 Yes. Α. -- "at the time of the first checkup using 10 Q. cancer occurrence data described below. Follow-up was 11 12 considered ended if a person either left the program or 13 died of another cancer, " right? 14 Α. Yes. 15 Q. "The study was narrowed down to 25,600 married 16 couples, who were identified as follows: For persons 17 who were in the membership database, which consists of a list of subscribers as of each June for a year of" --18 starting when? When did they start? 19 20 Α. 1976, it says. 21 Right. And they followed them for 31 years ο. 22 after that, right? 23 I'll show you. Let's go down to about -- four sentences down, 24 "Follow-up ended when a subject developed cancer or when 25 5274

1 a subject was no longer in our membership database or on November 30th, 1995, whichever first occurred." 2 3 Α. Okay. It says that. So they started following them in '76, and 4 ο. they followed them right through 1995, right? 5 6 A. That's what it says. Let's continue. Let's go back to the first 7 **Q**. 8 page. 9 Let's go to the first sentence. Keep going. "Cancer is known to have many environmental 10 11 causes." That's true, isn't it? 12 13 Α. Yes. 14 "Because married couples share at least Q. Okay. their home environment, usually for many years, the 15 16 study of spousal aggregation of cancer might provide 17 clues to unsuspected etiologic factors." That's true, isn't it? 18 19 A. It says that, yes. Sure. And how many years did Al and Alberta 20 0. Pilliod share a home? 21 Many years. I don't recall when they were 22 A. 23 actually married. 24 A long time? 0. A long time. 25 A. 5275

Q. Okay. Let's look at what they find. 1 2 Table 1, if we could, please. 3 In this only marital concordance study done after Roundup was on the market, they show, quote, an 4 association of cancer occurrence within married couples, 5 6 right? Yes. 7 Α. And let's go down and look at what they find 8 ο. 9 for non-Hodgkin's lymphoma. Non-Hodgkin's lymphoma. All right? 10 That's 11 what we're dealing with here, isn't it, non-Hodgkin's 12 lymphoma? Well, we're dealing with a very specific 13 Α. 14 entity within that. We're dealing with diffuse large B-cell lymphoma. There are at least 60 different kinds 15 16 of lymphoma. 17 Q. This will be the easiest question I ask all day. Did Al Pilliod have non-Hodgkin's lymphoma? 18 19 Yes, he did. Α. Did Alberta Pilliod get non-Hodgkin's lymphoma 20 0. four years later? 21 Yes, she did. 22 Α. 23 Okay. Non-Hodgkin's lymphoma, they find a Q. relative risk of 2.78, right, Doctor? 24 That's what it says, yes. 25 Α. 5276

Q. Statistically significant, right, Doctor? 1 Yes. 2 Α. 3 It's almost tripling of the risk, isn't it? 0. That's what they show. 4 Α. All right. And, in fact, they point out that 5 Q. 6 "one of the couples with non-Hodgkin's lymphoma had lived in Mexico for many years" --7 If we could pull that out. Thank you. 8 -- "for many years, and both husband and wife 9 were said to have been exposed there to pesticides, a 10 suspected cause of lymphoma." 11 Do you see that? 12 I do. 13 Α. Okay. So of all the cancers they looked at, 14 Q. they only found concordance in four types, right? 15 16 Well, they found concordance in follicular Α. 17 lymphoma in the couple that you just described. Is that what you mean? 18 19 Well, I'll go to -- if we could, to page 2416. Q. In the discussion section, second paragraph, 20 "For all cancers combined, there was no evidence of 21 spousal concordance. The only cancer sites which 22 23 statistically significant concordance was noted were the tongue" -- right? 24 25 Α. Yes.

1 Q. -- "stomach and non-Hodgkin's lymphoma," 2 right? That's what they say, right. 3 A. I have reviewed them carefully at this point. 21 At this point, right. Q. 22 Α. Yes. 23 Okay. Q. 24 Α. And to some extent when I wrote the paper. Ι had more months. I read it more, read it over. 25 But I 5280

4	study say, "Overall, in accordance with the evidence

All right. Have you looked at the Lamure paper that came out while Dr. Nabhan was here visiting 11 12 us? 13 Α. Which one? I'm sorry. Lamure study. It's Exhibit 3104. 14 Q. 15 Just real quick. 1 The result is they believe that his seizure A. 2 disorder, his abnormalities in the temporal lobes in his 3 brain are a result of the herpes simplex infection repeated over time; that the major cause of the 4 neurologic dysfunction related to five different 5 episodes of very severe brain infection, one of which 6 put him comatose for an entire month, apparently. 7 ο. Were those before he ever had non-Hodgkin's 8 9 lymphoma? Those were way before he ever had 10 A. non-Hodgkin's lymphoma. 11 So Mr. Miller asked you about the Leon paper 12 ο. that came out recently. 13 Yes. 14 Α. 15 And he directed your attention to Table 2. Q. 16 Α. Yes. 17 I want to go over some of the information he Q. didn't show you. I believe this is the data from that 18 19 table. Okay? 20 A. Yes. So they have a column here for non-Hodgkin's 21 ο. lymphoma malignancies overall. 22 23 Correct. Α. 24 Q. Do you see that? And with respect to glyphosate -- and this was 25 5291

1	data published last month what was the hazard ratio
2	for glyphosate?
3	A. The hazard ratio was less than 1. It was
4	0.95.
5	Q. And what is the significance, if any, to you
6	that this large recent study showed a hazard ratio of
7	.95?
8	A. It means to me that this large study has not
9	been able to show a statistically significant
10	relationship between glyphosate use and subsequent
11	development of non-Hodgkin's lymphoma.
12	Q. And with respect to the diffuse large B-cell
13	number that he directed your attention to, is that even
14	statistically significant by traditional statistical
15	measures?
16	A. No, it isn't. The confidence interval starts
17	at 1.00. So the most you can say is it's gray or
18	equivocal. It's a soft finding.
19	Q. Have you looked at other data on DLBCL and, in
20	fact, showed the jury this morning, in addition to the
21	Leon study, that looked at this question of DLBCL?
22	A. Yes, I have.
23	Q. Is there any indication of an increased risk
24	with that subtype?
25	A. No, not at all. Eriksson was mentioned as a

reference in one of the papers that I was asked, and 1 2 that paper was very clear. There was no statistical 3 incidence -- increase of diffuse large B-cell lymphoma. With respect to the methodology of looking at 4 Q. epidemiology, would you just look at one number to the 5 6 exclusion of all the other studies that you reviewed? These are really complicated areas. 7 Α. No. Ι feel badly for anyone who has to look at this. 8 It's 9 hard. And, really, you have to look at the entirety of 10 everything. 3	Mr. Miller spoke about, do the Zhang authors limit

8	Q. Do the Zhang authors include the entirety of
9	the Agricultural Health Study?
10	A. No. It says it does, but, really, the Zhang
11	went up to I believe it was 2010, 2011. So it's a
12	portion. It wasn't the updated Agricultural Health
13	Study database set.
14	Q. Do the Zhang authors include the Leon finding
15	of .95 that is reflected here?
16	A. Yes.
17	Q. I'm sorry. Does the Zhang study include the
18	updated Leon paper that just came out last month?
19	A. Oh, I see. No. I'm sorry.
20	Q. So continuing forward, counsel asked you some
21	questions about the spousal concordance paper, Friedman?
22	A. Yes.
23	Q. Do you recall that?
24	A. I do.
25	Q. There was what? Four couples in that paper?

Yes, there was four couples. 1 A. 2 And the studies that you talked about with the ο. 3 jury showing no spousal concordance, were those larger analyses? 4 Α. 2	it up a little bit on the so I can see the bottom of
3	the slide? I just want to see the years.
4	Yeah, I don't think it's a fair
5	representation. One small point is that it looks to me
6	as if the incidence of lymphoma is slightly going up
7	again. I don't believe that's true. That's one thing.
8	But, again, if you're looking on a scale, it
9	should be from 0 to 100. That's what it's supposed to
10	be. You can change the way it looks, but the data are
11	continuous, whether you graph it or not. What's
12	happened in lymphoma is a tremendous increase early in
13	the '80s, leveled off a bit in the '90s. By the 2000s,
14	it's flat; it's not increasing.
15	But at the same time just forget the curve.
16	At the same time, the use of glyphosate in the United
17	States is growing. It's more and more and more.
18	So however you want to put that on a graph,
19	lymphoma is not increasing and glyphosate use is.
20	Q. Thank you, Doctor.
21	Counsel showed you this article by Song on the
22	risk of developing other cancers following a nonmelanoma
23	skin cancer.
24	A. Yes.
25	Q. It's Exhibit 3157. And I just want to direct

1 your attention to what these authors say in their 2 conclusion here. 3 Trying to do this upside down is never a good idea. 4 MR. EVANS: Your other left. 5 BY MR. ISMAIL: 6 Let me back up here. We've --7 Q. Actually, can you pull up Exhibit 3157. 8 Turn to page 7 of the article and call up the last paragraph 9 above "References." 10 Does it say "We cannot estimate the recurrence 11 12 rate of nonmelanoma skin cancer or subsequent cancer 13 risk among people with multiple nonmelanoma skin cancers because we only recorded the first report of each type 14 of skin cancer in both cohorts"? 15 Yes, that's what it says. 16 A. 17 Does that describe Mr. Pilliod? ο. He had 22 -- well, he had 21 nonmelanoma 18 Α. No. skin cancers; he didn't have one. 19 20 0. And when you were looking at the data, did you 21 report on studies that showed what happens if you have multiple skin cancers and the risk of non-Hodgkin's 22 23 lymphoma? As the numbers of basal cell cancers, as 24 A. Yes. an example, goes up, the lymphoma risk goes up. 25 And 5299

it's not shown here. But, after 12 basal cells, it was 1 even a higher risk in that particular paper. 2 3 **Q**. And, Doctor, counsel asked you about red hair 4 and blue eyes. By any measure of those additional demographic 5 factors, is 22 skin cancers an unusual finding? 6 Yes, it is an unusual finding. 7 Α. Now, he asked you about CD4 count. 8 ο. 9 Yes. Α. 10 Q. Is that the only measure that you would look to to understand whether a patient's immune system is 11 functioning? 12 So the CD4 count would tell me the number 13 Α. No. of CD4 cells. It doesn't tell me the function of those 14 cells, just the number. And his number was normal. 15 16 But the more important issue is that there are 17 many, many, many components of the immune system. And the CD4 cell, the T4 cell, is only one example. 18 So I will say that the number of his T4 cells 19 I don't know about their function. 20 is normal. And I 21 don't know that he's ever been studied for any of the other immunologic abnormalities that might be really 22 underlying this. 23 Okay. So counsel -- almost done here. 24 **Q**. 25 Counsel asked you about this Chang paper. 5300

Do you recall that? 1 2 Yes. Α. So, first of all, he directed you to a 3 Q. particular sentence here about B-cell lymphomas. 4 Do you recall that? 5 Yes, I do. 6 A. What do these authors say immediately under 7 **Q**. that? 8 They say "Bias and confounding may account for 9 Α. the observed associations." Right in the abstract, 10 11 they're saying that this could be due to chance or bias alone. 12 And what do these authors say on their final 13 0. conclusion based on their review of this meta-analysis 14 15 data? Their conclusion is "Thus a causal 16 Α. 17 relationship has not been established between glyphosate exposure and risk of any type of lymphohematopoietic 18 19 cancer"; i.e., lymphoma would be in that category. And he asked you about B-cell lymphoma in this 20 0. study. But did they also report on diffuse large B-cell 21 lymphoma in this study? 22 23 Yes, they did. Α. 24 And if you turn to page 15, what was the data 0. they reported here for diffuse large B-cell lymphoma? 25 5301

They reported that, for diffuse large B-cell 1 A. 2 lymphoma, the meta RR was 1.1, but the 95 percent confidence interval showed that this was not 3 significant. 4 And so when we're talking about Mr. Pilliod's 5 Q. risk, Doctor, is it more important to look at the type 6 of cancer he had, diffuse large B-cell, or this 7 heterogeneous cancer called B-cell lymphoma? 8 9 Α. I said it at the beginning. And I can't even 10 emphasize it enough. Lymphoma is not one disease. And to say lymphoma is associated with X, Y, Z, that's one 11 piece of information. 12 But he has a very specific disease: 13 diffuse large B-cell lymphoma. And it's important to know that 14 these are different diseases. And we need to 15 concentrate on what Mr. Pilliod had. 16 17 Thank you, Doctor. A couple last topics real Q. quick. 18 Mr. Miller asked you some questions about 19 20 surfactants and their role in formulating a product. 21 You told us that Roundup is an herbicide; is that 22 correct? 23 Α. Yes. So, with respect to the role of surfactants 24 0. and what they do, would that relate to the efficacy or 25 5302

1 the effectiveness of it as a herbicide? Yes, because it can get into the leaves of the 2 Α. plants, for example. 3 Is that what you were referring to earlier 4 ο. about getting into the body of the leaf? 5 That's what I meant, the leaf. 6 Α. Yes. MR. MILLER: Objection. Leading. 7 BY MR. ISMAIL: 8 9 Can you talk to us about that? Q. 10 A. It's used in agricultural use. And it stops the plants from making certain proteins, amino acids. 11 And the ability to get this into the plant leaf would 12 be -- or into the plant itself would be important for 13 that product. 14 15 Does it have anything to do with getting it Q. 16 into a person? 17 It's hard to get through the skin of Α. No. people, actually, glyphosate. 18 19 Q. Okay. So, with respect to what Mr. Miller wrote up 20 21 here -- I think he wrote it up here. I have no idea whether he wrote it up here, 22 but thank you for that clarification. 23 Last topic, Doctor. With respect to the 24 things that Mr. Miller wrote up here on this chart -- I 25 5303

1 don't know if you can still see it -- you wrote down a 2 couple of the factors he talked about on direct 3 examination. Did he leave off a very important risk factor 4 that you talked with the jury about? 5 Immunity, I quess. But it's hard for me to 6 A. read. I can't read his handwriting. 7 I can't either. I think that says "obesity," 8 ο. 9 actually. 10 A. Okay. But let me ask it this way: What was 11 0. Mr. Pilliod's most significant risk factor for 12 developing NHL? 13 There's just no question in my mind. 14 Α. Takinq the whole totality of this, his immune system was 15 clearly abnormal. He had an autoimmune disease where 16 17 his own immune system thinks that his colon is foreign He had severe infections of the brain, five of 18 to him. them, due to the virus that causes cold sores in most of 19 20 us. He had 22 skin cancers. And multiple skin cancers 21 is a risk factor for eventual development for lymphoma. All of these working through the immune system 22 23 in a sense. And Mr. Miller asked you whether it's true 24 Q. that, anytime people develop the cancer, there's some 25 5304

1 failure of the immune system to protect that person. 2 Α. Yes. 3 **Q**. Is it something different when we're talking about Mr. Pilliod with respect to his immune system? 4 Mr. Pilliod's immune system has been 5 Α. Yes. 6 abnormal at least since his 20s, developing diseases that just don't occur in -- over and over again, and so 7 forth. 8 9 Age was mentioned. And age is a risk factor 10 for cancer. Our immune systems, all of us, the immune system gets weaker as we age, not enough to cause 11 opportunistic infections and so forth, but weak enough 12 13 to get some of us in trouble with cancer and not recognizing the cancer. 14 15 And you told the jury that, because ο. 16 Mr. Pilliod doesn't have one of the known causes of 17 cancer, you'd characterize it as idiopathic. That's correct. 18 Α. And what percentage of DLBCL patients have 19 Q. 20 idiopathic cancers? 90 percent. Some people say as high as 95 21 Α. 22 percent. 23 So, with respect to what he wrote here, 0. "Dr. Levine did not know what caused Al Pilliod's NHL," 24 25 where would that put Mr. Pilliod in the population of 5305

1 patients who develop his type of cancer? 2 It would put him within 90 percent of all Α. 3 patients with lymphoma. None of us know. We don't know what that cause is in the vast majority, in 90 percent 4 of people. 5 And that's true with him. His abnormal immune 6 system -- whatever caused this, his abnormal immune 7 system would have truly allowed this to occur, without 8 9 question. Would that increase his risk? 10 Q. 11 A. It would increase his risk substantially. 12 MR. ISMAIL: Thank you. 13 Your Honor, no further questions. MR. MILLER: Real quick. 14 15 **RECROSS-EXAMINATION** BY MR. MILLER: 16 17 It sounds like you think Mr. Pilliod is more Q. susceptible to getting non-Hodgkin's lymphoma because of 18 19 his immune system. 20 MR. ISMAIL: Objection. I'll allow it. 21 THE COURT: BY MR. MILLER: 22 23 So are you saying that his immune system Q. problem was a substantial contributing factor to causing 24 non-Hodgkin's lymphoma or not? Or are you saying you 25 5306
1 don't know the cause? 2 Which is it? 3 Α. I'm saying we don't know the cause in Mr. Pilliod or in the other 90 percent of people who 4 have diffuse large B-cell lymphoma. We don't know. 5 I don't know what his specific mutation -- his 6 specific type of mutation was. I don't know what it 7 8 was. 9 I do know that his very abnormal immune system would not have allowed him to recognize the first 10 malignant cell as foreign, and it would have been 11 allowed to continue. 12 13 Have a safe trip back to Los Angeles. **Q**. Thank you very much. 14 A. Thank you, Dr. Levine. 15 THE COURT: 16 THE WITNESS: Thank you. 17 THE COURT: So, ladies and gentlemen, we 18 are -- I'm sorry. 19 We're done for the day. Hold on just a 20 second. We're done for the day. We are not going to 21 be in session tomorrow because I need to talk to the 22 23 lawyers about a number of issues to get prepared for closing and submission of final evidence. So we will 24 not be in session tomorrow. We will start at 9:00 on 25 5307

1 Wednesday morning with jury instructions and closing 2 arguments. 3 Keep in mind we will not be here on Friday, even though you will begin deliberating before Friday, 4 because we have that day off. I think we discussed 5 6 So we're not going to be in session this Friday. that. So we will be in session Wednesday and Thursday. 7 So, while we have completed the evidence, you 8 9 have not heard any jury instructions. I don't want you to begin thinking about all of the evidence yet until 10 you've heard the jury instructions and the closing 11 arguments of both plaintiff and defense counsel. So 12 13 hold on for one or two more days, and then you can talk away about the evidence. 14 15 I'll see you on Wednesday morning at 9:00. 16 Thank you. 17 (The following proceedings were heard out of the presence of the jury:) 18 THE COURT: How about 10:00 tomorrow morning? 19 20 Does that work for everybody to start working on 21 finishing up the jury instructions? I assume you guys need to meet and confer about evidence or to make final 22 23 decisions about what's going to be admitted? MR. EVANS: Yeah, there are a few defense 24 25 exhibits that we've been back and forth on we probably 5308

will have to raise with Your Honor. There's not too 1 2 many, I don't think. 3 MR. ISMAIL: So we didn't formally rest, Your Honor; but, if we did, it would be subject --4 THE COURT: You didn't actually rest. I just 5 was talking to the jury about kind of where we were in 6 terms of --7 MR. ISMAIL: Subject to the admission of 8 9 exhibits. 10 THE COURT: Sure. No, no, I'm not resting for 11 you. 12 All right. So I'll see you guys tomorrow 13 morning at 10:00. MR. WISNER: And I think, Your Honor, based on 14 15 your ruling today, we don't anticipate calling any rebuttal testimony. We're ready to go for closings. 16 17 **THE COURT:** Why don't I get an estimate on the time -- are you closing? 18 MR. WISNER: Yes, your Honor. 19 20 THE COURT: I want to get an idea of how long 21 your closing is going to be. If we're really going to finish closing on Wednesday -- and I don't think the 22 jury instructions are going to take too, too long, 23 because there aren't that many. We'll probably have to 24 25 have some hard stops. So figure out exactly how much 5309

1 time plaintiffs will get and defense will get. 2 MR. WISNER: And for budgeting time, should we 3 assume an hour for housekeeping and jury instructions? **THE COURT:** You mean tomorrow morning? 4 MR. WISNER: Wednesday morning. 5 THE COURT: I think housekeeping needs to 6 happen tomorrow. Hopefully, we're going to start with 7 jury instructions right away on Wednesday morning. 8 9 MR. WISNER: Okay. 10 **THE COURT:** So once we finish up, I'll have copies of the instructions. Once we get a final set, I 11 12 guess what will have to happen is, once I make all my 13 final rulings, somebody will have to clean them up and send them back. I will make copies for the jurors. 14 15 We were going to request --MR. MILLER: 16 there's been a large demand for public attendance at the 17 close -- if it was possible to consider a larger courtroom for closing argument. 18 19 THE COURT: There's no larger courtroom 20 available. I'll try to set up a few extra chairs like I 21 did for opening. But that's the best I can do. MR. MILLER: Understand. 22 23 THE COURT: Sorry. MR. MILLER: Thank you, Your Honor. 24 25 MR. WISNER: Thank you. 5310

3	chat tomorrow morning.
